THIS AGREEMENT made in triplicate this 16 TM day of September, 1985 A.D.

BETWEEN:

THE CORPORATION OF THE TOWN OF PELHAM

Hereinafter called the "Town"

- and -

WILLIAM KEITH & MYRNA MARLENE FURTNEY

Hereinafter called the "Owners"

WHEREAS the Owners purport to be the Owners of the subject lands described in Schedule "A" attached to this Agreement;

AND WHEREAS the Owner is desirous of connecting the lands with the Town's water and sanitary sewer systems;

AND WHEREAS the Town has agreed to allow the Owners to connect their lands to the Pelham Water System and Sewer System, subject to certain terms and conditions;

NOW THEREFORE THIS AGREEMENT WITNESSETH that in consideration of the covenants herein contained the Town and the Owners covenant and agree as follows:

- (1) The Town will permit the Owners to connect to the existing watermain lateral located on the south side of Quaker Road. The Owners shall pay to the Corporation of the Town of Pelham the sum of Five Hundred & Sixty-Five Dollars (\$565.00) as their share of the expense of the watermain and lateral.
- (2) The Owners, at their own expense, will construct a 3/4" diameter PVC 150 PSI pipe or Type K copper water service from the lot line of their property to service the dwelling unit on their property.
- (3) The Town will permit the Owners to connect to the existing sanitary sewer lateral located on the south side of Quaker Road. In addition, the Owners shall pay to the Corporation of the Town of Pelham the sum of Two Thousand, Two Hundred and Seventy-Two Dollars (\$2,272.00) as their share of the expense of the main sanitary sewer trunk line and lateral.

- (4) The Owners, at their own expense, will construct a sanitary sewer service from the lot line of their property to service the dwelling unit on their property. Such sanitary sewer service shall meet or exceed the standards as set out in the Ontario Plumbing Code.
- (5) The Owners further agree to pay for the cost of a water meter and all the water and sewer useage charges as levied from time to time by the municipality.
- (6) This Agreement is to be binding on the Owners, their heirs, executors, administrators, successors, assigns forever and shall be registered against the title of the Owners as decribed in Schedule "A".
