BY-LAW #1028 (1985)

Being a by-law to dedicate a one foot reserve - Block 27, Plan 59M-100 - Cynthia Court as public highway.

WHEREAS Council considers it desirable to dedicate as a public highway the public lands herein described;

AND WHEREAS the said lands are now situate in the Town of Pelham;

NOW THEREFORE COUNCIL OF THE CORPORATION OF THE TOWN OF PELHAM ENACTS AS FOLLOWS:

(1) THAT Block 27, Plan $59\dot{\text{M}}$ -100 be and is hereby laid out, opened and dedicated for the use of the public as a public highway and be known as part of Cynthia Court.
