WHEREAS the Owner purports to be the Owner of the subject lands described in Schedule "A" attached to this Agreement;

AND WHEREAS the Owner is desirous of connecting the lands with the Town's water system;

AND WHEREAS the Town has agreed to allow the Owner to connect her lands to the Pelham Water System, subject to certain terms and conditions;

NOW THEREFORE THIS AGREEMENT WITNESSETH that in consideration of the covenants herein contained the Town and the Owners covenant and agree as follows:

- (1) The Town will permit the Owner to connect to the existing watermain lateral located on the south side of Quaker Road. The Owner shall pay to the Corporation of the Town of Pelham the sum of Five Hundred & Sixty-Five Dollars (\$565.00) as her share of the expense of the watermain and lateral.
- (2) The Owner, at her own expense, will construct a 3/4" diameter PVC 150 PSI pipe or Type K copper water service from the lot line of her property to service the dwelling unit on her property.
- (3) The Owner further agrees to pay for the cost of a water meter and all the water useage charges as levied from time to time by the municipality.

(4) This Agreement is to be binding on the Owner, her heirs, executors, administrators, successors, assigns forever and shall be registered against the title of the Owner as described in Schedule "A".
