BY-LAW #1088 (1986)

Being a by-law to provide for the erection
of stop signs at intersections.

WHEREAS Section 117 of the Highway Traffic Act,
R.S.O. 1980, Chapter 198 provides that the Council of a
municipality may by by-law provide for the erection of stop signs
at intersections on highways under its jurisdiction and every
sign so erected shall comply with the regulations of the
Ministry;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF
THE TOWN OF PELHAM ENACTS AS FOLLOWS:

(1) THAT the intersections on highways set out in
Column 1 are designated as intersections where stop signs shall
be erected at the locations shown in Column 2.

<u>Column 1 - Intersections</u>	<u>Column 2 - Facing Traffic</u>
Hurricane Road-Station Street	Southbound on Station Street
Pelham Street-Shorthill Place	Westbound on Shorthill Place
Brock Avenue-Petronella Parkway	Northbound on Petronella Parkway
Nursery Road-Fern Gate	Northbound on Fern Gate
Welland Road-Fern Gate	Southbound on Fern Gate
Haist Street-Kevin Drive	Westbound on Kevin Drive
Quaker Road-Kevin Drive	Southbound on Kevin Drive
Pancake Lane-Pickwick Place	Southbound on Pickwick Place
Spruceside Crescent-Cynthia Court	Southbound on Cynthia Court
Forest Hill Crescent-Green Vale Court	Northbound on Green Vale Court
Forest Hill Crescent-Whitehall Gate	Southbound on Whitehall Gate


Fallingbrook Drive-Brookbank Crescent	Southbound on Brookbank Crescent
Fallingbrook Drive-Brookbank Crescent	Eastbound on Brookbank Crescent
Woodstream Boulevard-Forest Hill Crescent	Westbound on Forest Hill Crescent
Berkwood Place-Haist Street	Eastbound on Berkwood Place
Berkwood Place-Vista Drive	Eastbound on Vista Drive
Berkwood Place-Kathy Court	Southbound on Kathy Court
Berkwood Place-Berkhout Terrace	Southbound on Berkhout Terrace

(2) THAT the penalties provided in Section 188 of the Highway Traffic Act shall apply to offences against this by-law.

(3) THAT each designation made by Section (1) shall not become effective until said signs have been erected in accordance with the regulations of the Highway Traffic Act.
