- 1. That every covenant, condition, proviso and stipulation contained in the said agreement, registered as Instrument No. 305943, will apply and bind the Corporation in the same manner and with the same effect as if the Corporation had been a party to the said agreement, and the Corporation covenants and agrees with the Town to do, observe, keep and perform every such covenant, condition, proviso and stipulation.
- 2. This Agreement and everything contained herein shall extend to and bind and enure to the benefit of the respective administrators, successors and assigns of the Parties hereto.
