

THE CORPORATION OF THE
TOWN OF PELHAM
BY-LAW NUMBER 125 (1971)

Being a by-law to declare the desirability of undertaking certain works as a local improvement under the provisions of Section 8, Paragraph 1 of the Local Improvement Act.

WHEREAS the Council of the Corporation of the Town of Pelham has determined that it is desirable that the work hereinafter described should be undertaken as a local improvement without petition:


THEREFORE The Municipal Council of the Corporation of the Town of Pelham by a vote of two-thirds of all the members thereof enacts as follows:

1. That it is hereby declared that it is desirable that an 8-inch diameter watermain extension be constructed on the following named street between the points hereinafter mentioned, namely:

STREET	FROM	TO
North Pelham St.	A point approximately 1,030 ft. north of Hurricane Road	A point approximately 1,614 ft. north of Hurricane Road

2. That notice of this Council's intention to undertake the said work in the form annexed to this by-law be published as required by the said Act.
3. That By-law #71 (1970) be and the same is hereby repealed.

PASSED AT a meeting of the Council duly called and held on the 22nd. day of November , 1971 by a vote of $\frac{2}{3}$ of all the members of Council..

2. The estimated cost of the said respective works, the amounts to be paid by the Ratepayers, the amounts to be paid by the Corporation, the estimated cost per foot frontage, the estimated annual rate per connection, the estimated rate per connection and the number of equal annual instalments in which the special assessment is to be paid are shown in Columns 5, 6, 7, 8, 9, 10, 11 and 12 above.

3. Application will be made by the Corporation to the Ontario Municipal Board for its approval of the undertaking of the said works and any owner may, within twenty-one days after the first publication of this notice, file with the Town Clerk named below, his objection to the work being undertaken.

4. The said Board may approve the said work being undertaken, but before doing so it may appoint a time and place where any objections to the said works will be considered.
