- (3) Mountainview has requested an amendment to the Drainage Plan which is attached as Schedule "K" to the said Subdivision Agreement.

NOW THEREFORE WITNESSETH that in consideration of the premises and of other valuable consideration, the parties hereto agree as follows:

1. The Drainage Plan attached as Schedule "K" to the

Subdivision Agreement entered into between 741689 Ontario Limited and The Corporation of the Town of Pelham, which is attached to the Document General registered in the Land Registry Office at Welland on the 11th day of August 1989, as Instrument No. 561421, is hereby deleted from the said Subdivision Agreement and that the Lot Grading Plan attached hereto as Schedule "K" is substituted therefor as Schedule "K" to the said Subdivision Agreement.
