I agree that the revocation by Council of any licence granted shall not entitle the licence holder to any refund of the licence fee or any part thereof, unless otherwise specifically provided by the relevant licence and by-law.

I further covenant and agree with the Corporation of the Town of Pelham that any person charged with by-law enforcement or with inspection of licenced premises by the Corporation shall have the right of entry upon the licenced premises described in this application at all reasonable times for purposes of inspection or enforcement of the licence by-law and I covenant, promise and agree in consideration of the issue of this licence as applied for, to indemnify and save harmless and keep indemnified the Corporation of the Town of Pelham, its officers, servants and agents, for any action, claim or damage, arising out of said entry or anything legally done by such person so entering.
