THIS AGREEMENT made in triplicate this 7574 day of July 1991.

BETWEEN:

MARION STIRTZINGER, of the Village of Fenwick, Regional Municipality of Niagara;

(hereinafter called "Stirtzinger")

OF THE FIRST PART;

-and-

THE CORPORATION OF THE TOWN OF PELHAM, in the Regional Municipality of Niagara;

(hereinafter called the "Town")

OF THE SECOND PART.

- 1. WHEREAS Stirtzinger and the Town entered into a Development Agreement dated August 21, 1989 and registered on September 7, 1989 as Instrument Number 563749;
- 2. AND WHEREAS Schedule "B" attached to the Agreement was amended and it is now desirable to register the amended Schedule "B".

NOW THEREFORE WITNESSETH THAT in consideration of the sum of One Dollar (\$1.00) of lawful money of Canada now paid by Stirtzinger to the Town (the receipt thereof is hereby acknowledged), the Parties hereto mutually covenant and agree as follows:

- 1. Stirtzinger and the Town hereby agree that Schedule "B" attached to Instrument Number 563749 is hereby rescinded and a new Schedule "B" dated, revised October 26, 1989 attached hereto is hereby substituted.
- 2. The Town confirms its approval of the amended Schedule "B" by By-Law No. 1414 (1991).

IN WITNESS WHEREOF the parties hereto have hereunto set their Corporate Seals under the hands of officers duly authorized in that behalf.




