THE CORPORATION OF THE TOWN OF PELHAM BY-LAW #1440 (1991)

Being a by-law to authorize an application to the Minister of the Environment pursuant to the Environmental Assessment Act with respect to the proposed Niagara Road #12 Landfill Site.

WHEREAS the Municipalities of Grimsby, Lincoln, Pelham and West Lincoln, in 1983, initiated an Environmental Assessment process with respect to the disposal of waste in the four Municipalities;

AND WHEREAS the Environmental Assessment process has resulted in the preparation of a Document entitled "The Solid Waste Management Master Plan for the Municipalities of Grimsby, Lincoln, Pelham and West Lincoln" prepared by Proctor & Redfern Limited dated September, 1991;

AND WHEREAS the Environmental Assessment process has been described in a book entitled "The Environmental Assessment Summary Document" prepared by Proctor & Redfern Limited, dated September, 1991, and has been further summarized in a document entitled "The Environmental Assessment Executive Summary Document" prepared by Proctor & Redfern Limited dated September, 1991;

AND WHEREAS, as a part of the Environmental Assessment process there has also been prepared a Social Impact Assessment for the proposed Niagara Road #12 Landfill Site for the Municipalities of Grimsby, Lincoln, Pelham and West Lincoln, which report was prepared by the Institute of Environmental Research (1985) Inc. dated September, 1991 and a Public Consultation Report with respect to the proposed Niagara Road #12 Landfill Site, prepared by the Town of Grimsby, dated September, 1991;

AND WHEREAS the Municipalities of Grimsby, Lincoln, Pelham and West Lincoln, have, by agreement dated the 23rd. day of June, 1988, agreed to establish a Board of Management which shall be responsible to advise the Councils of the four Municipalities with respect to waste disposal;

AND WHEREAS the four Municipalities authorized the Board of Management to act as their agent and to bring all necessary applications and to take all actions necessary to acquire a site for the construction and operation of the waste disposal site, subject to the ratification of the Councils of four Municipalities;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWN OF PELHAM ENACTS AS FOLLOWS:

- (1) The conclusions and recommendations contained in the following reports are hereby adopted:
 - (a) The Solid Waste Management Master Plan of the Municipalities of Grimsby, Lincoln, Pelham and West Lincoln, prepared by Proctor & Redfern Limited, dated September, 1991;
 - (b) The Environmental Assessment Summary Document for the Municipalities of Grimsby, Lincoln, Pelham and West Lincoln, prepared by Proctor & Redfern Limited dated September, 1991;
 - (c) The Environmental Assessment Executive Summary document for the Municipalities of Grimsby, Lincoln, Pelham and West Lincoln, prepared by Proctor & Redfern Limited dated September, 1991;
 - (d) The Social Impact Assessment for the proposed Niagara Road #12 Landfll Site for the Municipalities of Grimsby, Lincoln, Pelham and West Lincoln, prepared by the Institute of Environmental Research (1985) Inc. dated September, 1991;
 - (e) The Public Consultation Report with respect to the proposed Niagara Road #12 Landfill Site, prepared by the Town of Grimsby, dated September, 1991.
- The Board of Management, established pursuant to the agreement between the four Municipalities dated June 23, 1988, is hereby authorized to submit, on behalf of the four Municipalities to the Minister of the Environment, pursuant to the Environmental Assessment Act, R.S.O. 1980, Chapter 140, as amended, Part II, the Environmental Assessment documents described above with the request that the Minister accept the Environmental Assessment and that the Minister give her approval to proceed with the understanding, the Niagara Road #12 Landfill Site.
- The Mayor and the Clerk are hereby authorized to execute the submission of the Environmental Assessment to the Minister of the Environment and such further documentation as may be necessary in support of that application and to affix the Corporate Seal thereto.

(4) The Board of Management is hereby authorized to commence a formal review of the solid waste management master plan within five years of the date hereof.
