THE CORPORATION OF THE TOWN OF PELHAM BY-LAW NO. 1441 (1991)

Being a by-law to authorize an application for a certificate of approval pursuant to the Environmental Protection Act with respect to the proposed Niagara Road #12 Landfill Site.

WHEREAS the Municipalities of Grimsby, Lincoln, Pelham and West Lincoln have by by-law adopted conclusions and recommendations of the Solid Waste Management Master Plan for the four Municipalities, prepared by Proctor & Redfern Limited dated September, 1991;

AND WHEREAS the Councils of the four Municipalities have authorized, by By-law, an application to the Minister of the Environment pursuant to the Environmental Assessment Act seeking approval of an Environmental Assessment;

AND WHEREAS the said Master Plan and Environmental Assessment have concluded that it is desirable to establish a landfill site to serve the four Municipalities which landfill site is known as the proposed Niagara Road #12 Landfill Site;

AND WHEREAS by agreement dated the 23rd. day of June, 1988, the four Municipalities did create a Board of Management for the purpose of advising the Councils of the four Municipalities with respect to waste disposal;

AND WHEREAS the Board of Management has recommended that an application be made pursuant to the Environmental Protection Act, R.S.O. 1980, Chapter 141, as amended, seeking a Certificate of Approval to permit the establishment, use and operation of the proposed Niagara Road #12 Landfill Site;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWN OF PELHAM ENACTS AS FOLLOWS:

- (1) The conclusions and recommendations contained in the following reports are hereby adopted:
 - (a) Supporting documentation to an application for a Certificate of Approval, proposed Niagara Road #12 Landfill Site, Volume 1 Main Report, prepared by Proctor & Redfern Limited dated September, 1991;

- (b) Supporting documentation to an application for a Certificate of Approval, proposed Niagara Road #12 Landfill Site, Volume II Technical Reports, prepared by Proctor & Redfern Limited dated September, 1991;
- (c) Phase 3 Hydrogeologic Study of Proposed Niagara Road #12 Landfill Site prepared by Morrison Beatty dated September, 1991.
- (2) The Board of Management, established pursuant to the between provisions of an agreement the Municipalities dated the 23rd. day of June, 1988, is authorized to submit, pursuant to the hereby Environmental Protection Act, 1980, Chapter 141, as amended, Part V, an application for a Certificate of Approval for the proposed Niagara Road #12 Landfill Site together with the supporting documentation referred to in Section 1 hereof.
- (3) The Mayor and Clerk are hereby authorized to sign the application for a Certificate of Approval pursuant to the Environmental Protection Act for the establishment, use and operation of the proposed Niagara Road #12 Landfill Site and to execute such further documentation as may be necessary in support of that application.
