A BY-LAW TO CHANGE THE NAME OF HILLCREST ROAD (between South Pelham Street and Effingham Road) TO PANCAKE LANE

WHEREAS Section 354 (1) 97 of the Municipal Act,

R.S.O. 1970 Chapter 284 provides that By-laws may be passed by
the Councils of local municipalities for changing the names of
highways by a vote of at least three-fourths of all the manabers
of Council.

AND WHEREAS with the advent of Regional Government there is confusion and duplicity of certain street names in the Town of Pelham.

BE IT THEREFORE ENACTED BY THE COUNCIL OF THE CORPOR-ATION OF THE TOWN OF PELHAM AS FOLLOWS:-

1. THAT the name of Hillcrest Road, between Lots 1, 2, 3 4 and 5, Concessions 8 and 9 of the former Township of Pelham, between South Pelham Street and Effingham Road, be changed to Pancake Lane.

THIS BY-LAW WITH THE CERTIFICATE OF THE JUDGE of the Judicial District of Niagara South attached, shall take effect from and after their registration thereof in the Registry Office for the Registry Division of Niagara South.
