THE CORPORATION OF THE TOWN OF PELHAM

BY-LAW NO. 1561(1993)

Being a by-law to dedicate certain lands as public highway and to name the lands "Maureen Court".

AND WHEREAS the Council of the Corporation of the Town of Pelham deems it desirable and necessary to dedicate, as a public highway, the lands herein described and to name the lands "Maureen Court";

AND WHEREAS the said lands are situated in the Town of Pelham;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWN OF PELHAM ENACTS AS FOLLOWS:

- (1) THAT Part 1 on Reference Plan 59R-7678 being Part of Block 19, Registered Plan 59M-128, in the Town of Pelham, in the Regional Municipality of Niagara be dedicated for the use of the public as a public highway;
- (2) THAT the public highway described in Section (1) be named "MAUREEN COURT".
- (3) THAT this by-law shall come into force and effect upon the registration of the by-law in the Registry Office for the Registry Division of Niagara South.
