THE CORPORATION OF THE TOWN OF PELHAM

BY-LAW NO. 1666(1994)

Being a by-law to dedicate Parts 2 and 3 on Reference Plan 59R-8046 as a public highway.

WHEREAS the Land Division Committee of the Regional Municipality of Niagara has granted approval of Consent Applications #B210/91 and #B211/91 subject to a condition that the owner dedicate a 2 metre road widening along the entire frontage of Part 1 and 4 on Giles Crescent;

AND WHEREAS the Council of the Corporation of the Town of Pelham deems it desirable and necessary to dedicate, as a public highway, the lands herein described;

AND WHEREAS the said lands are situated in the Town of Pelham;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWN OF PELHAM ENACTS AS FOLLOWS:

- (1) THAT Parts 2 and 3 on Reference Plan 59R-8046 be dedicated for the use of the public as a public highway;
- (2) THAT this by-law shall come into force and effect upon the registration of the by-law in the Registry Office for the Registry Division of Niagara South.
