

BY-LAW NUMBER 192, 1973.  
OF THE CORPORATION OF THE TOWN OF PELHAM

A BY-LAW TO AUTHORIZE THE EXECUTION OF  
AN AGREEMENT WITH HER MAJESTY THE QUEEN  
IN RIGHT OF THE PROVINCE OF ONTARIO  
REPRESENTED BY THE MINISTER OF TRANSPOR-  
TATION AND COMMUNICATIONS FOR THE PROVINCE  
OF ONTARIO.

WHEREAS an Agreement has been presented to Council by the Minister of Transportation and Communications with respect to the reconstruction of that part of Highway No.20 from Pelham to Allanburg by the Province of Ontario and installation of oversized storm sewers between Stations 399 + 90 and 418 + 58 to accommodate the future development of lands lying south of these stations and now said to be owned by Kenmore Construction Limited.

AND WHEREAS the terms upon which the Province will construct the oversize storm sewer are set out in the said Agreement and are acceptable to Council on the basis that the additional cost will be recovered by Council from Kenmore Construction Limited.

NOW THEREFORE THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE TOWN OF PELHAM ENACTS AS FOLLOWS:-



2. THAT the Mayor and Clerk be and each of them are hereby authorized and instructed on behalf of the Corporation to execute the said Agreement and the Clerk is hereby authorized to affix the Corporate Seal thereto.


