#### **SPECIAL PROVISIONS:**

Pursuant to the exception provisions of Section 11:

- 1. Notwithstanding Subsection 6 (e), at 1363 Effingham Street the fence along the east side of the privately-owned outdoor swimming pool may be erected not less than 1.35 m (4.43 ft.) from the water's edge;
- 2. Notwithstanding the height provisions of Section 5, fences in the rear yards of those lots adjacent to the westerly boundary of Pelham Street from the intersection of Merritt Road and Pelham Street to the north side of Welland Road at its intersection with Pelham Street may be erected and maintained to a height of not greater than 1.82 m (6 ft.) above the centre line of Pelham Street;
- 3. Notwithstanding Subsection 6 (e), at 14 Michaela Crescent the fence along the west side of the privately-owned outdoor swimming pool may be erected not less than 1.2 m (3.94 ft.) from the water's edge.
- 4. Notwithstanding the height provisions of Section 5, the fence along the westerly lot line may be erected to a maximum fence height of 2.15 m (7'-0") on the property known municipally as 12 Cherry Ridge Boulevard.

Notwithstanding the height provisions of Section 5, fences in the rear yards of those lots adjacent to the westerly boundary of Pelham Street from the intersection of Merritt Road and Pelham Street to the north side of Welland Road at its intersection with Pelham Street may be erected and maintained to a height not greater than 1.82 m (6 ft.) above the centre line of Pelham Street.
