

BY-LAW NUMBER 202, 1973.

OF THE CORPORATION OF THE TOWN OF PELHAM.

A BY-LAW TO AUTHORIZE THE EXECUTION OF A
QUIT CLAIM DEED FOR PREMISES COMMONLY
KNOWN AS PART LOT 12, SOUTH SIDE EAST
CANBORO ROAD, IN THE VILLAGE OF FENWICK,
ACCORDING TO PLAN 16 FOR THE TOWNSHIP OF
PELHAM.

WHEREAS the Trustees of the Police Village of Fenwick
did by Deed dated the 29th day of June, 1945 and registered as No. 15236
for the Township of Pelham acquire an interest in part of Lot 12 on the
south side of Canboro Road in the Village of Fenwick according to regis-
tered Plan 16 for the Township of Pelham for the purpose of sinking a well
for fire protection.

AND WHEREAS the Council of the Town of Pelham, the
successors in title to the said premises by virtue of the Regional Muni-
cipality of Niagara Act R.S.O. 1970, Chapter 406, is satisfied that the
said well is no longer required for fire protection in the Municipality.

AND WHEREAS application has been made by the current
owners of the said premises, to the Municipality, to release any interest
it may have in the said premises.

NOW THEREFORE THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE TOWN OF
PELHAM ENACTS AS FOLLOWS:


1. THAT a Quit Claim Deed for that part of Lot 12 on the south side of east Canboro Road in the Village of Fenwick according to registered Plan 16 for the Township of Pelham as described in Deed registered as No.15326, to Pentti Piironen and Paula Piironen, a copy of which is attached hereto and made a part of this By-law, BE AND THE SAME IS HEREBY APPROVED.

2. THAT the Mayor and Clerk be and each of them are hereby authorized and instructed on behalf of the Corporation to execute the said Deed and affix thereto the Corporate Seal and deliver the same to the applicants.
