THE CORPORATION OF THE

BY-LAW NO. 2103 (1999)

Being a by-law to dedicate a one foot reserve designated as Part 7 on Reference Plan 59R-10787 as a public highway and to name the lands "Maple Street".

WHEREAS the Council of the Corporation of the Town of Pelham deems it desirable and necessary to dedicate, as a public highway, the lands herein described and to name the lands "Maple Street";

AND WHEREAS the said lands are situated in the Town of Pelham;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWN OF PELHAM ENACTS AS FOLLOWS:

- (1) THAT the one foot reserve designated as Part 7 on Reference Plan 59R-10787 be dedicated for the use of the public as a public highway.
- (2) THAT the public highway described in Section (1) be named "MAPLE STREET".
- (3) THAT this by-law shall come into force and effect upon the registration of the by-law in the Registry Office for the Registry Division of Niagara South.
