## THE CORPORATION OF THE TOWN OF PELHAM

BY-LAW NO. 2131 (1999)

Being a by-law to release certain lands from a site plan agreement

WHEREAS the Council of The Corporation of the Town of Pelham deems it desirable to release certain lands from a site plan agreement, dated the 5<sup>th</sup> day of October, 1990, and registered on the 16<sup>th</sup> day of October, 1990, as instrument No. 594984 between The Corporation of the Town of Pelham and GEOS Company Limited and Supreme Central Realty Inc. c.o.b. as Canboro Garden Apartments (the "Site Plan Agreement").

## NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWN OF PELHAM ENACTS AS FOLLOWS:

- (1) **THAT** the lands described in Schedule "A" are hereby released from the terms of the Site Plan Agreement.
- (2) **THAT** the Mayor & Clerk be and each of them is hereby authorized and instructed on behalf of the Corporation of the Town of Pelham to execute the necessary release and to register same on title to the lands described in Schedule "A".
