## THE CORPORATION OF THE TOWN OF PELHAM BY-LAW NO. 2227 (2000)

Being a by-law to dedicate Parts 1 & 2 on Reference Plan 59R-11174 as a public highway and to name the lands "Canboro Road".

- (3) THAT this by-law shall come into force and effect upon the registration of the by-law in the Registry Office for the Registry Division of Niagara South.
