

THIS AGREEMENT made in duplicate this 13th day of March , 2001 and authorized by By-law No. 2001-32 of the City of St. Catharines

BETWEEN:

THE CORPORATION OF THE CITY OF ST. CATHARINES

(hereinafter called "St. Catharines")

OF THE FIRST PART

- and -

THE CORPORATION OF THE TOWN OF PELHAM

(hereinafter called "PELHAM")

OF THE SECOND PART

ADDENDUM

WHEREAS the parties have entered into an agreement on the 4^{th} day of May, 1998, and are desirous of extending the said term of the agreement to the end of December, 2001.

NOW THEREFORE THIS AGREEMENT WITNESSETH that in consideration of the mutual covenants and agreements herein contained and subject to the terms and conditions hereinafter set out, the parties hereto agree as follows:

- 1. That the agreement dated the 4th day of May, 1998, between St. Catharines and Pelham shall continue to be in force and effect with the following amendments:
 - i) The parties hereto agree that the said agreement shall be extended from the 31st day of December, 2000 to the 31st day of December, 2001.

- That notwithstanding the provisions of the said agreement dated the 4th day of May, 1998, the parties hereto agree that for the year 2001, the applicable rate payable by Pelham to St. Catharines shall be an increase of 2.3 per cent from the rate paid in the year 2000.
- iii) The parties agree that all other provisions contained in the said agreement dated May 4, 1998, save and except as varied by this addendum shall continue to be in force and effect and binding upon the said parties.
