

THE CORPORATION OF THE  
TOWN OF PELHAM  
BY-LAW #2377 (2002)

Being a by-law to amend By-law #1615 (1994), as amended, being a by-law to regulate the supply of water and to provide for the maintenance and management of the waterworks and for the imposition and collection of water rates.

WHEREAS the Council of the Corporation of the Town of Pelham deems it necessary to increase the water rates to those buildings which are furnished with water by the Town of Pelham;

AND WHEREAS the Council of the Corporation of the Town of Pelham deems it necessary to increase the rate to be charged to water haulers effective May 1<sup>st</sup>., 2001;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWN OF PELHAM ENACTS AS FOLLOWS:

- (3) THAT Schedule "A" to By-law #1615 (1994), be and is hereby deleted and that Schedule "A" attached hereto and forming part of this by-law be substituted in its place.
- (2) THAT this by-law shall come into force and take effect as of the date of passing.



# SCHEDULE

BY-LAW #2377 (2002)

## WATER RATES

### 1. **Metered Rates [Section 8 (a)]**

(a) For all consumers except as noted in (b)

Minimum Rate - For the first 12,000 gallons (54.55m<sup>3</sup>) or part thereof \$22.00 per four month billing period.

Overage - For all water consumed in excess of 12,000 gallons (54.55m<sup>3</sup>) per four month billing period - \$2.42 per 1,000 gallons or .532 cu meter

(b) For the homes serviced on Sumbler Road

Minimum Rate - For the first 8,000 gallons (36m<sup>3</sup>) or part thereof - \$33.28 per four month billing period.

Overage - For all water consumed in excess of 8,000 gallons (36m<sup>3</sup>) per four month billing period - \$3.10 per 1,000 gallons or .682 cu meter

### 2. **Water Loading Station Rates - [Section 8 (a)]**

A flat rate of \$4.14 per 1,000 gallons or .910 cu meter to be billed effective May 1<sup>st</sup>, 2002.

### 3. **Multiple Occupancy Rates [Section 8 (a)]**

Where more than one self-contained dwelling unit exists and is supplied through a common water meter, multiple water rates shall be charged. Similarly, wherever multiple business establishments are operated through a common meter, multiple rates shall be charged.

4. **Water for Construction Rates [Section 8 (j)]**

Pursuant to Section 8 (5) a flat rate of \$25.00 for residential and \$50.00 for commercial or industrial construction shall be charged.

5. **Administration Charge [Section 8 (a)]**

A \$10.00 charge over and above all charges shall apply to all new or changed accounts.

6. **Penalties [Section 8 (a)]**

A penalty of 10% shall be applied to all accounts not paid by the due date.

7. **N.S.F. Charges [Section 8 (a)]**

A charge of \$20.00 shall be added to any account for which a cheque has been issued and such cheque is returned by the bank for reason of insufficient funds.

8. **On and Off Charges [Section 4 (p)]**

The charge for turning the water supply on or off to a private water service, other than a new service shall be as follows:

Monday to Friday - 7:00 a.m. to 3:30 p.m. - \$60.00 flat rate (excluding holidays)

Monday to Friday - 3:30 p.m. to 7:00 a.m. - \$100.00 flat rate (excluding holidays)

Saturdays, Sundays & Holidays - 12:01 a.m. to midnight - \$125.00 flat rate

Flat rates shall be a basic rate and shall include both on and off charges regardless of when the respective services are carried out.

9. **Meter Testing [Section 7 (h)]**

The cost for testing a 5/8" meter at the owner's expense shall be \$50.00.

10. **New Water Meter and Remote Reader [Section 7 (c)]**

The capital contribution to the Town for water meters and remote readers, with the Town retaining ownership, shall be:

5/8" water meter	\$145.00
3/4" water meter or larger	actual cost

11. **Tapping Fees [Section 6 (1)]**

The fee for the Corporation to tap the main line and connect the water service to the waterworks - \$200.00.

12. **Permits [Section 5 (a)]**

The fee for permits to install services shall be:

Water Service	\$15.00
Private Water Service	\$15.00
