## THE CORPORATION OF THE TOWN OF PELHAM

BY-LAW NO. 2416 (2002)

Being a by-law to amend By-law No. 57 (1970), as amended, being a by-law to regulate the discharge of firearms within the limits of the Town of Pelham.

WHEREAS the Council of the Corporation of the Town of Pelham has expanded the urban boundary limit from the Fonthill urban area easterly to Rice Road (Regional Road 54) to provide for future urban development;

AND WHEREAS the Council of the Corporation of the Town of Pelham, in the interest of public safety, deems it advisable to enlarge the area to include the expanded urban boundary in which the discharge of any gun or other firearm, air-gun or spring-gun or any class or type thereof is prohibited;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWN OF PELHAM ENACTS AS FOLLOWS:

(1) That Section 1 of By-law No. 57 (1970) is hereby amended by adding the following:

## Area #7

Commencing at the intersection of Highway 20 (Regional Road #20) and Station Street; Thence north-easterly along the south side of Highway 20 (Regional Road #20) to the intersection with Rice Road (Regional Road #54);

Thence southerly along Rice Road to a point 1,667 feet south of Merritt Road;

Thence westerly 1,310 feet;

Thence northerly 330 feet;

Thence westerly 655 feet;

Thence southerly 309 feet;

Thence westerly 657 feet to Line Avenue;

Thence northerly along Line Avenue and continuing along Station Street to the point of commencement and being the area shown cross hatched on Schedule "A" attached to this bylaw.

## Area #8

Commencing at a point at Highway 20 (Regional Road #20) at the intersection with Lookout Street;

Thence southerly to a point 500 feet north of Canboro Road;

Thence south-westerly along a line parallel to and north of Canboro Road to the west limit of lot 4 in the 8<sup>th</sup> concession;

Thence northerly to Highway 20 (Regional Road #20);

Thence easterly to the point of commencement and being the area shown cross hatched on Schedule "A" attached to this by-law.

- (2) That Schedule "A" of By-law No. 57 (1970), as amended, be deleted and that the attached Schedule "A" be substituted therefore.
- (3) That Section (7) of By-law No. 57 (1970) be deleted and the following Section (7) be substituted therefore:

- Every person who contravenes any of the provisions of this by-law is guilty of an "(7) offence and liable upon conviction to a penalty as prescribed under the Provincial Offences Act."
- (4) That this by-law shall come into force, take effect and be passed on the third reading and final passage thereof.
