ADDENDUM

WHEREAS the parties have entered into an agreement on the 7th day of May, 2003, and are desirous of extending the said term of the agreement to the end of December, 2005;

NOW THEREFORE THIS AGREEMENT WITNESSETH that in consideration of the mutual covenants and agreements herein contained and subject to the terms and conditions hereinafter set out, the parties hereto agree as follows:

- 1. That the agreement dated the 7th day of May, 2003, between St. Catharines and Pelham shall continue to be in force and effect with the following amendments:
- (i) The parties hereto agree that the said agreement shall be extended from December 31, 2004, to December 31, 2005.
- (ii) That notwithstanding the provisions of the said agreement dated the 7th day of May, 2003, the parties hereto agree that for the year 2005 the applicable rate payable by Pelham to St. Catharines shall be an increase of 5.28% to the rate paid in the year 2004.

(iii) The parties agree that all other provisions contained in the said agreement dated May 7th, 2003, save and except as varied by this addendum shall continue to be in force and effect and binding upon the said parties.


