WHEREAS the Owner represents and warrants that it is the owner of the lands in the Town of Pelham described in Schedule "A" attached hereto (the "Lands");

AND WHEREAS the Town has previously entered into a Site Plan Agreement with 766432 Ontario Inc. and 706014 Ontario Inc., which Agreement (the "Site Plan Agreement") is dated September 16, 1996 and registered against title to the Lands as Instrument No. 713783 on October 7,1996;

**AND WHEREAS** the Owner has assumed and agreed to be bound by the terms and conditions of the Site Plan Agreement;

AND WHEREAS the Owner is desirous of constructing a garage for the sole purpose of repairing and maintaining the fleet of trucks in accordance with Schedule "B" attached hereto and filed in the Town's offices;

AND WHEREAS the Town has agreed to permit the said construction subject to certain terms and conditions;

AND WHEREAS it is necessary to amend the Site Plan Agreement;

NOW THEREFORE THIS AGREEMENT WITNESSETH that in consideration of the sum of One Dollar (\$1.00) now paid by the Owner to the Town (the receipt whereof is hereby acknowledged), the Parties hereto mutually covenant and agree as follows: -

- 1. The Site Plan Agreement is hereby amended by deleting Schedule "B" attached thereto and replacing it with the Schedule "B" attached to this Agreement.
- 2. The Site Plan Agreement is hereby further amended by adding the following clauses:

Any notice mailed as aforesaid shall be deemed to have been given and received on the fifth day next following the date of its mailing.

## 26. SCHEDULES

The originals of the plans set out in the attached Schedules are available at the offices of the Town at the address set out in paragraph 25.

## 27. BINDING EFFECT

This Agreement shall be binding upon the parties hereto and their heirs, executors, administrators, successors, and assigns.

3. All other terms and conditions of the Site Plan Agreement shall remain in full force and effect except as amended herein and shall apply to this agreement.
