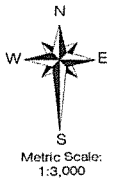

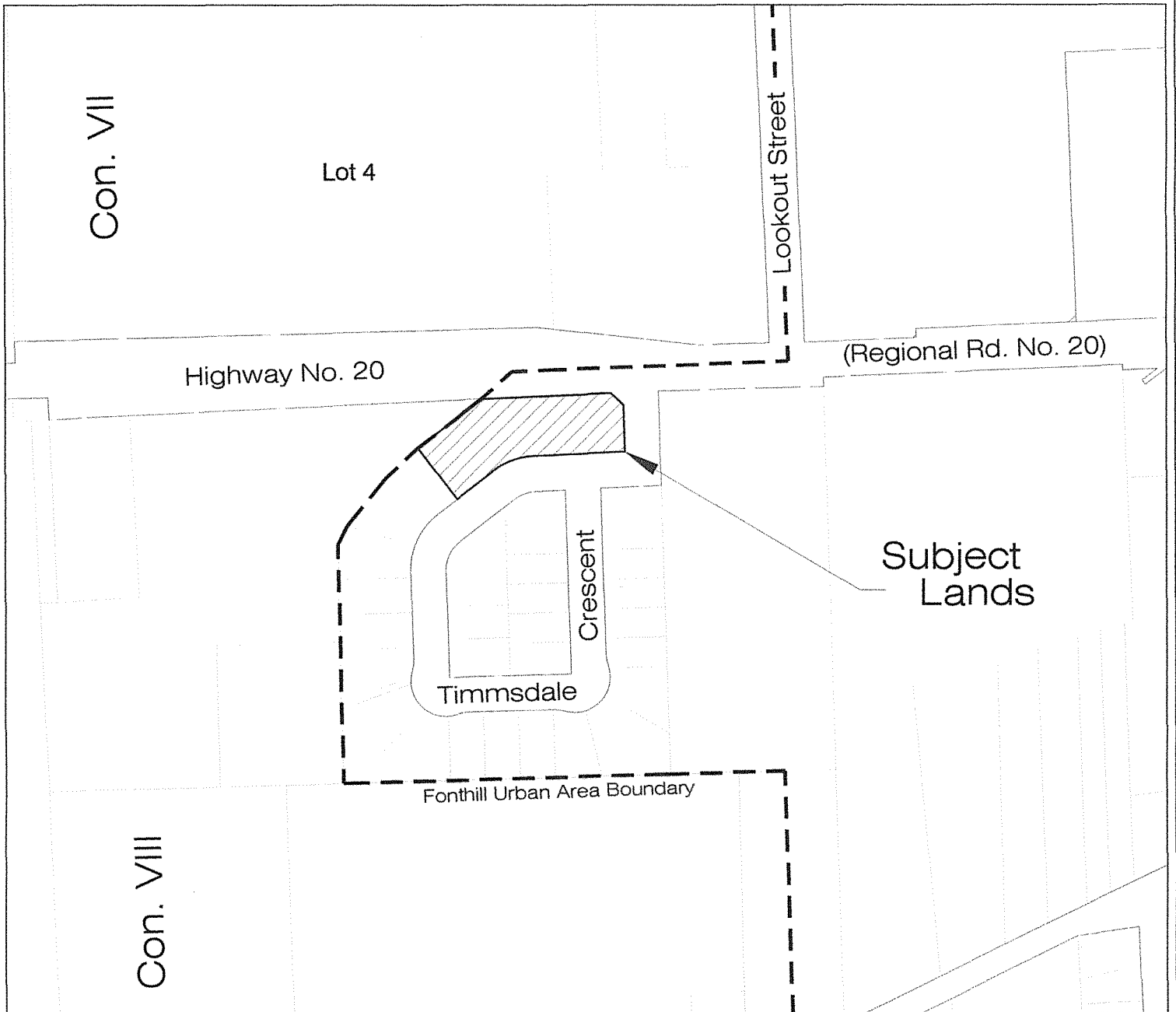

SCHEDULE 'A' - KEY MAP

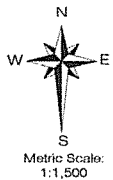

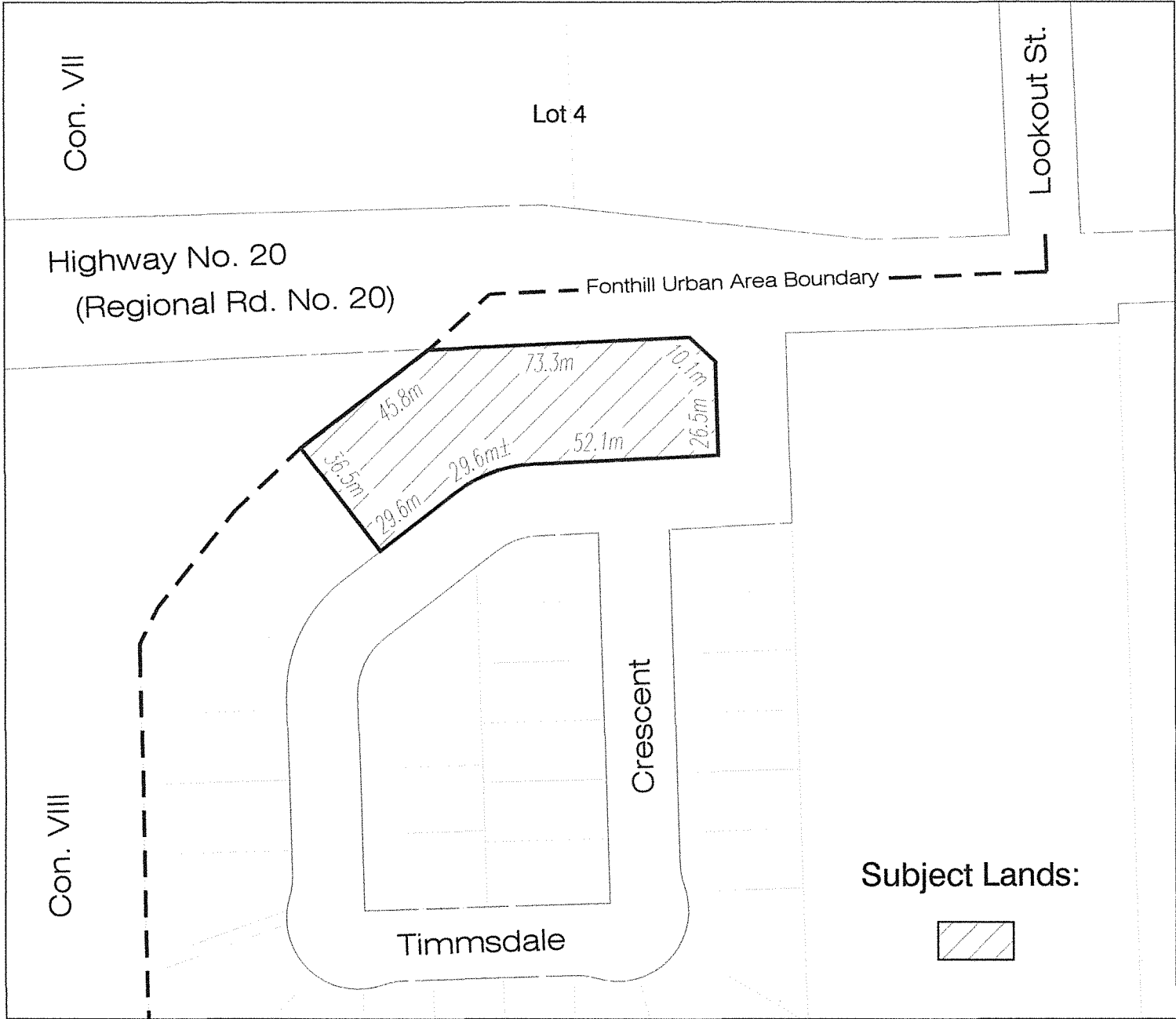

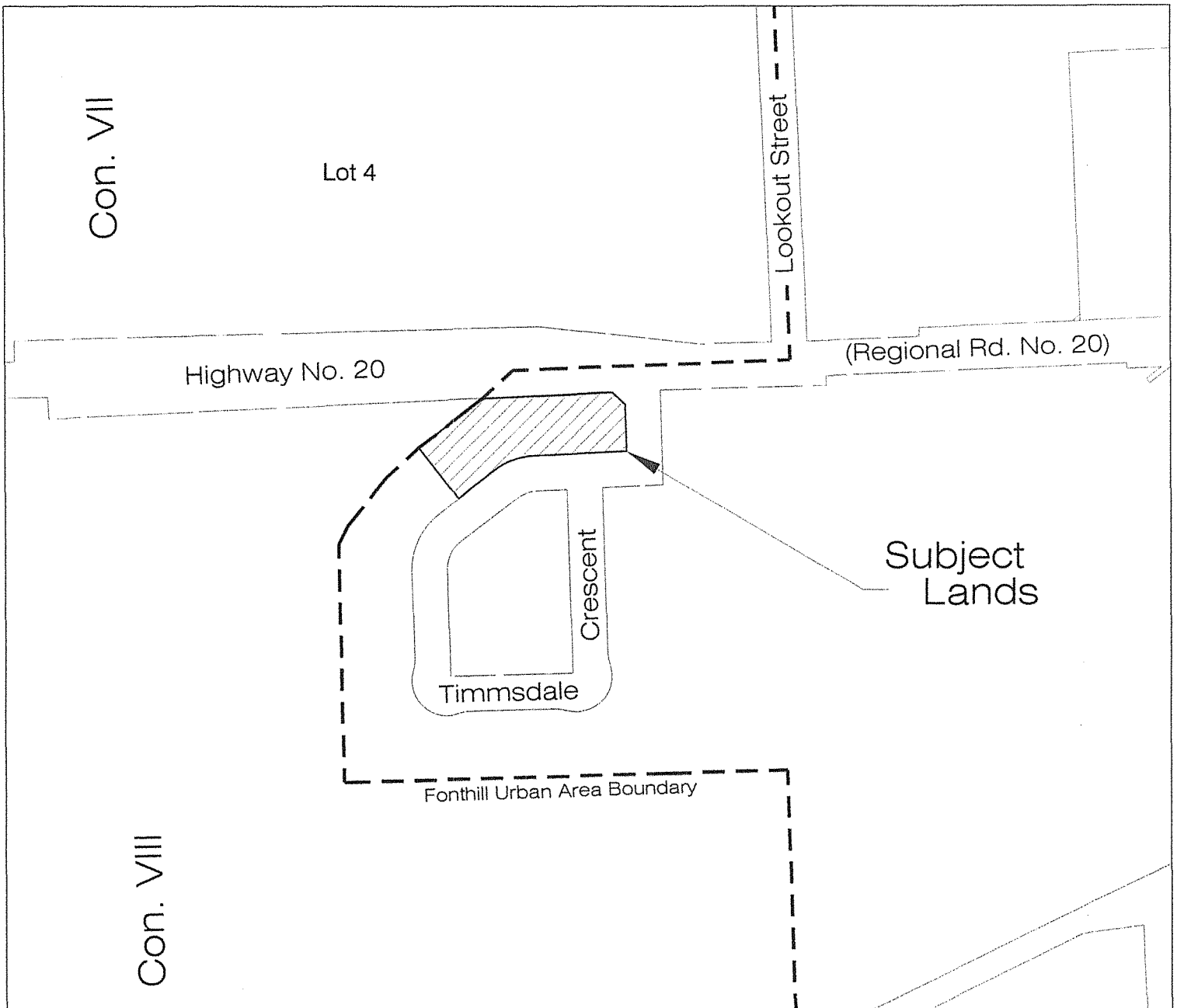

SCHEDULE 'A' - KEY MAP

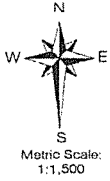

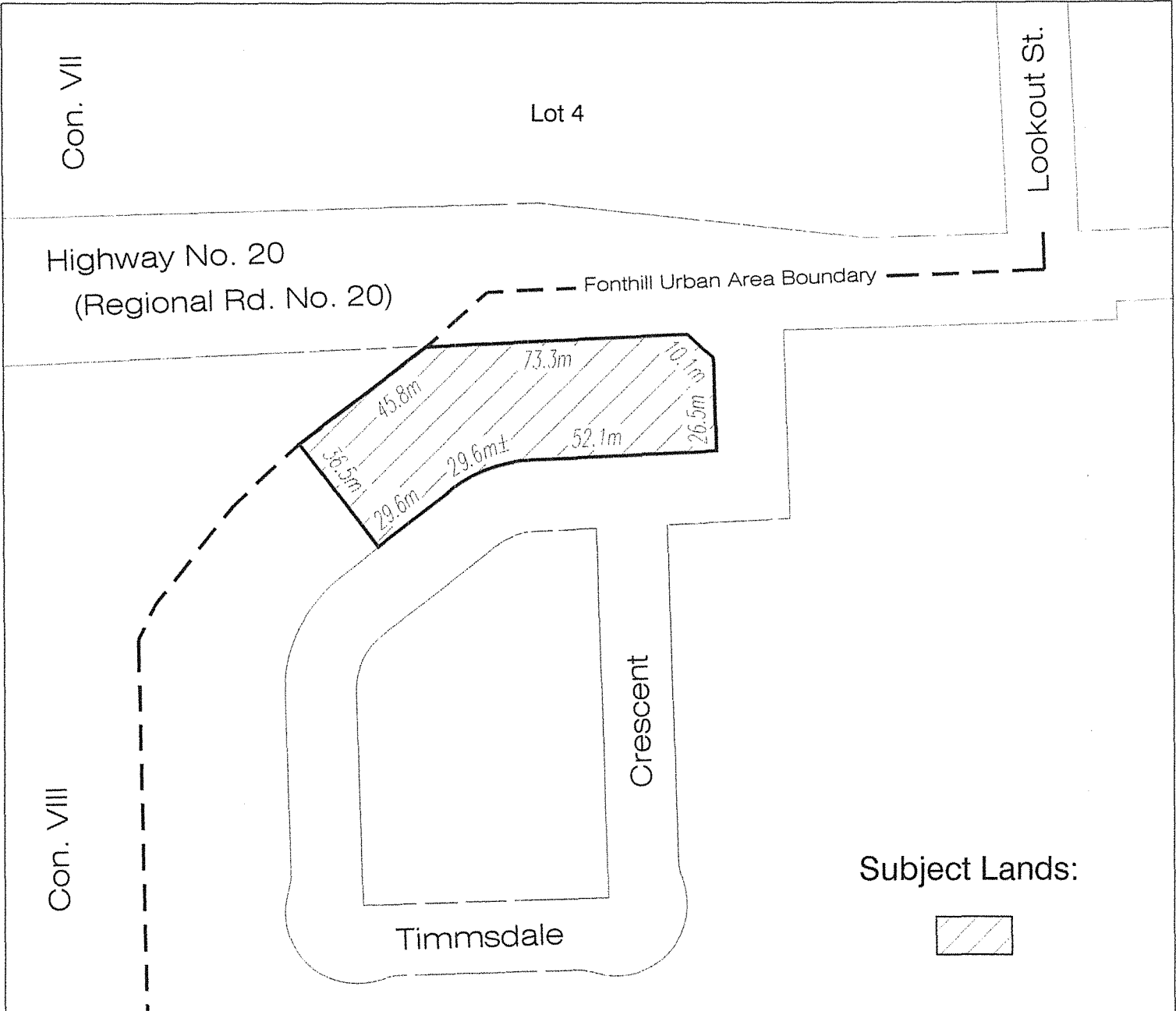
