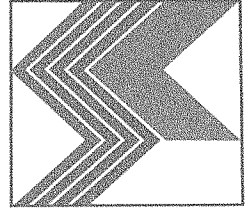

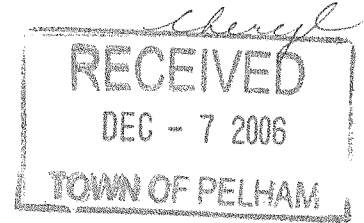

ADDENDUM

THIS AGREEMENT made in duplicate this 30th day of November,
2006, and authorized by By-law No. 2006-322 of the City of St. Catharines.

B E T W E E N:

THE CORPORATION OF THE CITY OF ST. CATHARINES

(hereinafter called "St. Catharines")

OF THE FIRST PART

- and -

THE CORPORATION OF THE TOWN OF PELHAM

(hereinafter called "Pelham")

OF THE SECOND PART

WHEREAS the parties have entered into an agreement on the 7th day of May, 2003, as amended on May 24, 2005, and February 9, 2006, and are desirous of extending the said term of the agreement to the end of December, 2007;

NOW THEREFORE THIS AGREEMENT WITNESSETH that in consideration of the mutual covenants and agreements herein contained and subject to the terms and conditions hereinafter set out, the parties hereto agree as follows:

1. That the agreement dated the 7th day of May, 2003, between St. Catharines and Pelham, as amended, shall continue to be in force and effect with the following amendments:

(i) The parties hereto agree that the said agreement shall be extended from December 31, 2006, to December 31, 2007.

(ii) That notwithstanding the provisions of the said agreement dated the 7th day of May, 2003, as amended, the parties hereto agree that for the year 2007 the applicable rate payable by Pelham to St. Catharines shall be \$43,773.00.



- (iii) The parties agree that all other provisions contained in the said agreement dated May 7th, 2003, as amended, save and except as varied by this addendum shall continue to be in force and effect and binding upon the said parties.

IN WITNESS WHEREOF the parties hereof have hereunto affixed their corporate seals under the hands of their proper officers duly authorized in that behalf.


