## THE CORPORATION OF THE TOWN OF PELHAM THE DRAINAGE ACT, R.S.O. 1990

BY-LAW NO. 2914 (2007)

Being a by-law to provide for a relocation of a portion of a drainage works in the Town of Pelham, known as the Cyrus Nunn Drain.

WHEREAS the Council of the Town of Pelham, in accordance with the provisions of Section 78 of the Drainage Act has appointed an engineer to prepare a report for the relocation of a portion of the Cyrus Nunn Drain as shown by Schedule "A" attached hereto and forming part of this By-law;

**AND WHEREAS** the Council of the Town of Pelham has procured the report made by Spriet Associates and the report is attached hereto and forms part of this By-law, as Schedule "B";

**AND WHEREAS** the estimated total cost of constructing the drainage work is \$7,600.00;

**AND WHEREAS** the Council is of the opinion that the relocation of the drain is desirable;

**NOW THEREFORE** the Council of the Corporation of the Town of Pelham **HEREBY ENACTS AS FOLLOWS**:

1. **THAT** the report dated September 27, 2007 and attached hereto is hereby adopted and the drainage works as therein indicated and set forth is hereby authorized and shall be completed in accordance therewith.

## 2. AND THAT:

(1) The Corporation of the Town of Pelham may borrow on the credit of the Corporation the amount of \$7,600.00 being the necessary amount for construction of the drainage works

## 3. AND THAT:

(1) For paying the amount of \$7600.00;

A special rate shall be levied upon lands and roads as set forth in Schedule "B", a copy attached hereto and forming for all purposes part of this By-law, to be collected in the same manner and at the same rate as other taxes are collected.

- 4. **AND THAT** this By-law shall be cited as the "Cyrus Nunn Drain Relocation By-law".
- 5. **AND THAT** this by-law shall come into force, take effect and be passed on the THIRD and FINAL reading hereof.
