1. That the agreement dated the 7th day of May, 2003, between St. Catharines and Pelham, as amended, shall continue to be in force and effect with the following amendments:

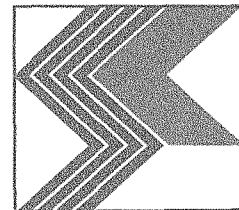
(i) The parties hereto agree that the said agreement shall be extended from December 31, 2007, to December 31, 2008.
