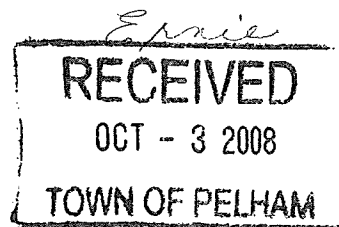

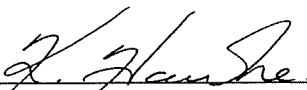
Re: Set Fines - Provincial Offences Act - Part I, Town of Pelham
