This information shall be provided to the Associate Director of Information Development and Mapping at the Regional Municipality of Niagara, 2201 St. David's Road, P. O. Box 1042, Thorold, Ontario L2T 4T7.
- (iv) The parties agree that all other provisions contained in the said agreement dated May 7th, 2003, as amended, save and except as varied by this addendum shall continue to be in force and effect and binding upon the said parties.


