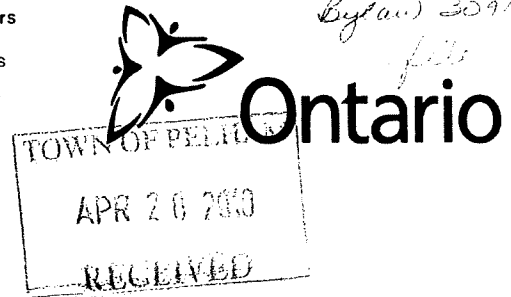

Re: Cemetery Price List for Fonthill Cemeteries

The cemetery Price List most recently returned to you and filed with the date of March 23rd 2009, has an error in the prescribed amounts set out for "Marker Care & Maintenance" as shown in item #6 on the Price List.

The prescribed amounts set forth in Regulation 132/92, Section 4 of the *Cemeteries Act (Revised)* are \$100 for an upright marker measuring 4 feet or less in height and 4 feet or less in length, including the base AND \$200 for an upright marker more than 4 feet in either height or length.

The amount of \$225 and \$375 shown in the "Total" column of Section 6 are to be changed to \$100 and \$200 respectively.

Any monument dealer who has been charged more than the prescribed amounts is entitled to a refund.
