#### Being a By-law to establish a Niagara Compliance Audit Committee for the Town of Pelham.

WHEREAS Section 81.1 of the *Municipal Elections Act, 1996* as amended provides that a council or local board shall, before October 1 of an election year, establish a compliance audit committee for the purposes of Section 81, and

WHEREAS it is deemed expedient to establish a compliance audit committee for the Town of Pelham related to the possible contravention of the said *Act* for election campaign finances;

NOW THEREFORE the Municipal Council of the Town of Pelham hereby enacts as follows:

- 1. THAT a Niagara Compliance Audit Committee be and it is hereby established.
- 2. THAT the Terms of Reference for the Niagara Compliance Audit Committee annexed hereto as Schedule "A" be and they are hereby authorized and approved and adopted.
- 3. THAT the Clerk of the Town of Pelham is hereby delegated the authority to effect any amendments to Schedule "A" hereto which may arise at the request of one of the Joint Area Participants subsequent to the passage of this by-law if deemed reasonable by the Clerk and Town Solicitor, and the Clerk shall notify the Council in such instance.

- 2. THAT By-law #3144(2010) be and is hereby repealed.
