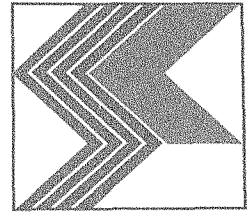


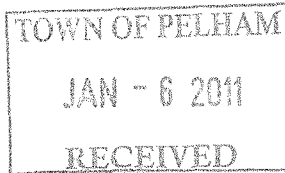

Please find enclosed herewith, for your records, two fully executed copies of the Computer-Aided Fire Dispatch Addendum Agreement between The Corporation of the City of St. Catharines and The Corporation of the Town of Pelham dated December 13, 2010. This addendum extends the term of the agreement dated May 7, 2003, as amended, between the City and the Town of Pelham to December 31, 2011, for the purpose of continuing computer-aided fire dispatch service and providing for a rate increase of 3% to the rate paid in 2010.

Please note that the above noted agreement was executed on behalf of the City of St. Catharines on December 30, 2010, however we have left the agreement dated December 13, 2010, being when it was executed on behalf of the Town of Pelham.

ADDENDUM

THIS AGREEMENT made in duplicate this *13th* day of *December*, 2010, and authorized by By-law No. 2010-291 of the City of St. Catharines.

BETWEEN:

THE CORPORATION OF THE CITY OF ST. CATHARINES
(hereinafter called "St. Catharines")

OF THE FIRST PART

- and -

THE CORPORATION OF THE TOWN OF PELHAM
(hereinafter called "Pelham")

OF THE SECOND PART

WHEREAS the parties have entered into an agreement on the 7th day of May, 2003, as amended on May 24, 2005, February 9, 2006, November 30, 2006, December 11, 2007, December 9, 2008, and January 11, 2010, and are desirous of further extending the said term of the agreement to the end of December, 2011;

NOW THEREFORE THIS AGREEMENT WITNESSETH that in consideration of the mutual covenants and agreements herein contained and subject to the terms and conditions hereinafter set out, the parties hereto agree as follows:

1. That the agreement dated the 7th day of May, 2003, between St. Catharines and Pelham, as amended, shall continue to be in force and effect with the following amendments:

(i) The parties hereto agree that the said agreement shall be extended from December 31, 2010, to December 31, 2011.

(ii) That notwithstanding the provisions of the said agreement dated the 7th day of May, 2003, as amended, the parties hereto agree that for the year 2011 the applicable rate payable by Pelham to St. Catharines shall be \$50,435.00.


(iii) The parties agree that all other provisions contained in the said agreement dated May 7, 2003, as amended, save and except as varied by this addendum shall continue to be in force and effect and binding upon the said parties.
