

Being a by-law to authorize the Mayor and Clerk to enter into Agreements with four establishments licensed by the Alcohol and Gaming Commission of Ontario that are situate within the Summerfest licensed area, those establishments being namely Mossimo's Pizzeria, Zest Restaurant, The Café on Main and Wine Bar, and Gelato Village for the purposes of obtaining a Special Occasion Permit for the Summerfest event to be held on Saturday, July 20th, 2013.

WHEREAS the Council of the Corporation of the Town of Pelham deems it desirable to enter into agreements with the four licensed establishments within the Summerfest licensed area to facilitate an application for a Special Occasion Permit, in accordance with the Regulations of the Alcohol and Gaming commission of Ontario, for the Summerfest event to be held on Saturday, July 20th, 2013 between the hours of 11:00 a.m. and 12:00 midnight, those establishments namely being Mossimo's Pizzeria, Zest Restaurant, The Café on Main and Wine Bar, and Gelato Village;

NOW THEREFORE COUNCIL OF THE CORPORATION OF THE TOWN OF PELHAM ENACTS AS FOLLOWS:

- (1) THAT the Agreements between Mossimo's Pizzeria, Zest Restaurant, The Café on Main and Wine Bar, and Gelato Village be and the same are hereby approved;
- (2) THAT the Mayor and Clerk be and are hereby authorized and instructed on behalf of the Corporation of the Town of Pelham to execute the said Agreements and the Clerk is hereby authorized to affix the Corporate Seal thereto.

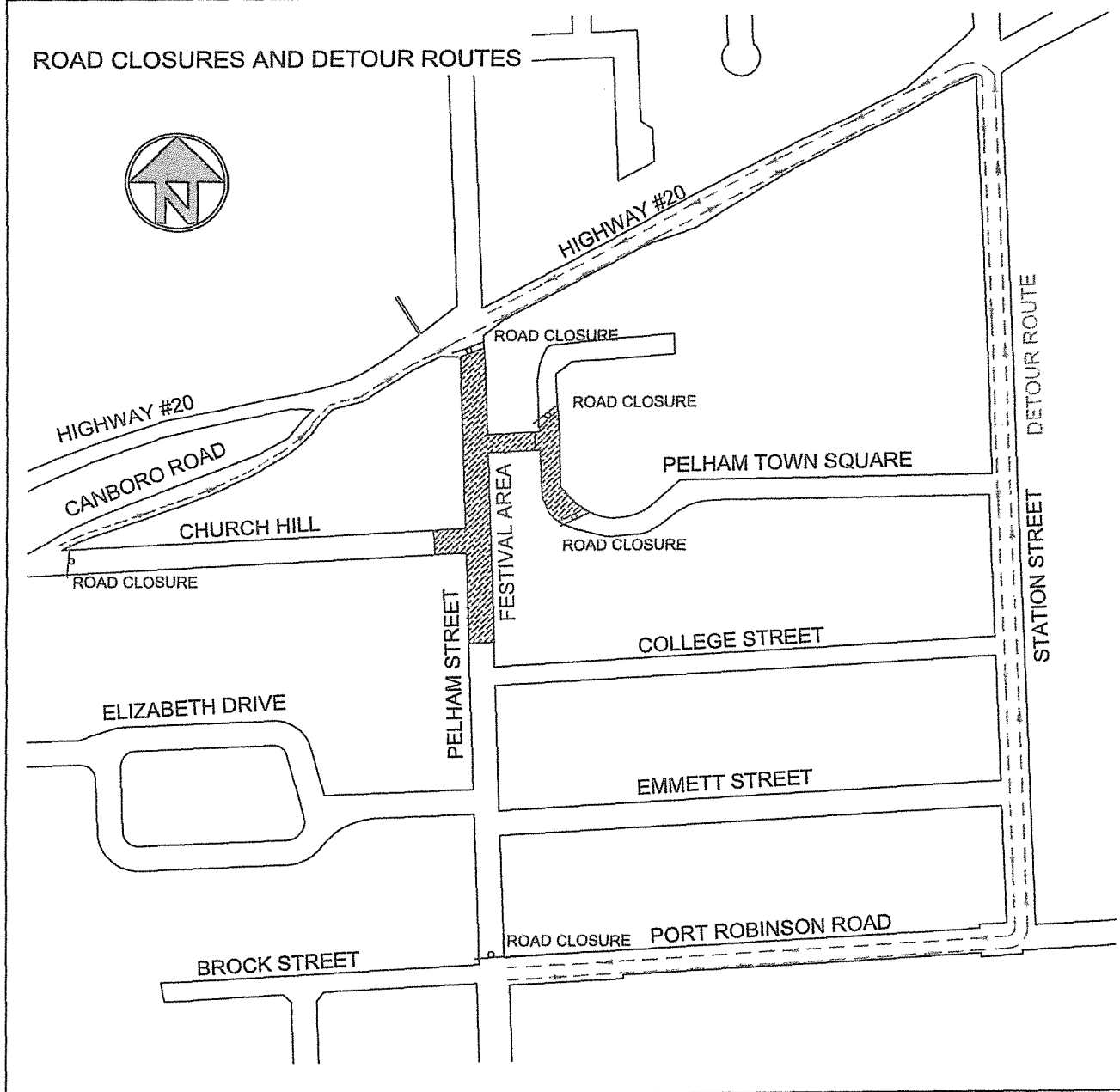

This aerial map illustrates the layout for a multi-day event in the Pelham Town Square area. The event zones are defined by 'X' marks indicating fences.

- Pelham Town Square:** A central area labeled 'AREA = 6700m2' designated for 'THURSDAY, FRIDAY' featuring 'ART IN THE PARK ENTERTAINMENT' and a 'WINE & BEER GARDEN'. It is bounded by Pelham Street to the north and Church Hill to the east.
- Street Festival Area:** A larger area labeled 'AREA = 6250 m2' and '(FENCED)' located south of Pelham Town Square. It includes a 'MAIN STAGE' and a 'BEER PAVILION'. A 'ROAD CLOSURE' is indicated along Pelham Street.
- Access Points:** Multiple 'ENTRANCE/EXIT GATE' locations are marked with arrows pointing to specific points along the fenced boundaries.
- Surrounding Streets:** The map shows 'PELHAM STREET' running horizontally, 'COLLEGE STREET' running vertically to the east, and 'HIGHWAY #20' running diagonally to the southwest.

LETTER OF UNDERSTANDING

And

MOSSIMO'S PIZZERIA; ZEST RESTAURANT FONTHILL; THE CAFÉ ON MAIN AND WINE BAR; GELATO VILLAGE

RE: PELHAM SUMMERFEST SATURDAY, JULY 20, 2013

Whereas the Town of Pelham entered into agreements with three establishments licensed by the Alcohol and Gaming Commission of Ontario that are situated within the Pelham Summerfest licensed area, those establishments being namely Mossimo's Pizzeria, Zest Restaurant, The Café on Main and Wine Bar, and Gelato Village for the purposes of obtaining a Special Occasion Permit for the Summerfest event to be held on Saturday, July 20, 2013.


In addition to the said agreement signed on May 21, 2013, the following is understood:


1. The boundaries of Licensed Festival Area will be confined by barricades and fencing.
2. There will be five monitored entrance/exit points to the designated Festival Area. These areas will be manned by Security Officers. Bag checks will be performed.
3. The Festival Committee will hire 2 Niagara Regional Police Officers, 2 Auxiliary Officers and 7 Security Guards (total of 11), from 11:00am July 21 till 1:00 am July 22, to monitor the five entrances/exits and for crowd monitoring.
4. Alcohol will not be allowed to enter into businesses not covered by this agreement, this will be posted and monitored accordingly.
5. All servers are Smart Serve Certified.
6. Outdoor patio capacity will be limited to available seating only and will be monitored accordingly by patio licensees.
7. The proposed beer pavilion will be operated in accordance with the Town of Pelham Municipal Alcohol Management Policy. (attached)

The Town of Pelham, establishment owners, liquor servers, all staff, event Committee and event security will all monitor alcohol within the event and licensed establishments to ensure a safe and responsible liquor controlled events.
