SCHEDULE "A" - PROHIBITED ANIMALS BY-LAW 0000-2013

ALL PROTECTED OR ENDANGERED ANIMALS BEING ALL ANIMALS, NATIVE OR NON-NATIVE, WHOSE POSSESSION OR SALE IS PROHIBITED BECAUSE THEY ARE DESIGNATED AS PROTECTED OR ENDANGERED PURSUANT TO AN INTERNATIONAL, FEDERAL, OR PROVINCIAL LAW, REGULATION, RULE OR AGREEEMENT, UNLESS THE ANIMAL HAS BEEN OBTAINED IN ACCORDANCE WITH INTERNATIONAL, FEDERAL OR PROVINCIAL LAW, AS APPLICABLE, AND IF THE ANIMAL IS NOT OTHERWISE IDENTIFIED IN THIS SCHEDULE.

ALL APALONE (INCLUDING, BUT NOT LIMITED TO: SMOOTH SOFT SHELL TURTLE, FLORIDA SOFT SHELL TURTLE, EASTERN SPINY SOFTSHELL TURTLE)

ALL ARTIODACTYLOUS UNGULATES, EXCEPT DOMESTIC GOATS, SHEEP, PIGS AND CATTLE,

ALL CANIDAE, (INCLUDING, BUT NOT LIMITED TO: WOLF, FOX, COYOTE, HYENA, DINGO, JACKAL, RACCOON DOG, BUSH DOG, AND ANY HYBRID OFFSPRING OF A WILD DOG AND DOMESTICATED DOG) EXCEPT THE DOMESTIC DOG (CANIS FAMILIARIS).

ALL CHEL YDRIDEA (INCLUDING, BUT NOT LIMITED TO: SNAPPING TURTLE AND ALLIGATOR SNAPPING TURTLE)

ALL CROCODILIANS (INCLUDING, BUT NOT LIMITED TO: ALLIGATORS AND CROCODILES) WITH THE EXCEPTION OF THE FOLLOWING THREE DWARF SPECIES - PALEOSUCHUS TRIGONATUS (SMOOTH-FRONTED DWARF CAIMAN), PALEOSUCHUS PALPEBROSUS (CUVIER'S DWARF CAIMAN), OSTEOLAEMUS TETRASPIS (AFRICAN DWARF CROCODILE)

ALL EDENTATES (INCLUDING, BUT NOT LIMITED TO: ANTEATERS, SLOTHS AND ARMADILLOS)

ALL ELEPHANTIDAE (ELEPHANTS)

ALL ERINACIDAE, EXCEPT THE AFRICAN PIGMY HEDGEHOG

ALL FELIDAE (INCLUDING, BUT NOT LIMITED TO: LION, TIGER, LEOPARD, OCELOT, JAGUAR, PUMA, PANTHER, MOUNTAIN LION, CHEETAH, WILD CAT, COUGAR, BOBCAT, LYNX, SERVAL, AND ANY HYBRID OFFSPRING OF A WILD CAT AND DOMESTICATED CAT), EXCEPT THE DOMESTIC CAT (FELIS CATUS).

ALL FRONT FANGED VENOMOUS SNAKES (EVEN IF DEVENOMIZED) INCLUDING, BUT NOT LIMITED TO, ALL VIPERIDAE (VIPER, PIT VIPER), ALL ELAPIDAE (COBRA, MAMBA, DRAIT, CORAL SNAKE), ALL ATRACTASPIDIDAE (AFRICAN BURROWING ASP), ALL HYDROPHIDAE (SEA SNAKE) AND ALL LATICAUDIDAE (SEA DRAIT)

ALL HYAENIDAE (HYENAS)

ALL MARSUPIALS (INCLUDING, BUT NOT LIMITED TO: TASMANIAN DEVIL, BANDICOOT, KANGAROO, WALLABY, OPOSSUM, WOMBAT, KOALA BEAR, CUSCUS, NUMBAT AND PIGMY, EXCEPT SUGAR GLIDERS)

ALL MUSTELIDAE (INCLUDING, BUT NOT LIMITED TO: SKUNKS, OTTERS, MARTEN, MINK, BADGER, ERMINE, SKUNK, OTTER, POLE CAT, WOLVERINE AND WEASELS) EXCEPT THE DOMESTIC FERRET (PUTORIUS FURO).

ALL NON-HUMAN PRIMATES (INCLUDING, BUT NOT LIMITED TO: GORILLAS, MONKEYS, APE, CHIMPANZEE, GORILLA AND LEMUR)

ALL PINNIPEDS (INCLUDING, BUT NOT LIMITED TO: SEALS, FUR SEALS AND WALRUSES)

ALL PERISSODACTYLOUS UNGULATES (INCLUDING BUT NOT LIMITED TO: ZEBRA, RHINOCEROS AND TAPIR), EXCEPT THE DOMESTIC HORSE AND ASS

ALL PROCYONIDAE (INCLUDING, BUT NOT LIMITED TO: RACCOONS, COATIS, KINKAJOU, CAT-BEAR, PANDA, COATIMUNDI AND CACOMISTLES)

ALL PITEROPODIDAE (BATS)

ALL RAPTORS, DIURNAL AND NOCTURNAL (INCLUDING, BUT NOT LIMITED TO, EAGLES, HAWKS AND OWLS)

ALL RATITES (INCLUDING, BUT NOT LIMITED TO, OSTRICHES, RHEAS AND CASSOWARIES)

ALL URSIDAE (BEARS)

ALL VENOMOUS REPTILES AND SNAKES (INCLUDING, BUT NOT LIMITED TO: GILA MONSTER, MEXICAN BEARDED LIZARD),

ALL VIVERRIDAE (INCLUDING, BUT NOT LIMITED TO, MONGOOSES, CIVETS AND GENETS)

ALL NON-VENOMOUS SNAKES WHICH HAVE THE POTENTIAL TO REACH AN ADULT LENGTH LARGER THAN 3 METRES (INCLUDING, BUT NOT LIMITED TO: RETICULATED PYTHON, BURMESE PYTHON, INDIAN PYTHON, AFRICAN ROCK PYTHON, AMETHISTINE PYTHON, GREEN ANACONDA AND YELLOW ANACONDA)

ALL VENOMOUS AND NON VENOMOUS LIZARDS WHICH HAVE THE POTENTIAL TO REACH AN ADULT LENGTH LARGER THAN 2 METRES (INCLUDING, BUT NOT LIMITED TO: KOMODO DRAGON)

ALL MEDICALLY SIGNIFICANT ARACHNIDA AND CHILOPODA INCLUDING VENOMOUS SPIDERS (INCLUDING, BUT NOT LIMITED TO: BLACK WIDOW, TARANTULA, SOLIFUGID, AND SOLIFUGID SCORPION)

ALL VENOUMOUS ARTHROPODS (INCLUDING, BUT NOT LIMITED TO: CENTIPEDE)

ALL SQUIRRELS (SCIURIDAE)

ALL SEA MAMALS (CETACEA, PINNIPEDIA AND SIRENA), INCLUDING, BUT NOT LIMITED TO: DOLPHIN, WHALE, SEAL, SEA LION, AND WALRUS.

ALL HYRAX (HYRACOIDEA).

ALL PANGOIL (PHOLIDOTA)

ALL INSECTIVOROUS MAMMALS (INSECTIVORA), INCLUDING, BUT NOT LIMITED TO: AARDVARK (TUBULIDENTATA), ANTEATER, SHREW, OTTER SHREW AND MOLE.

ALL OTHER VENOMOUS OR POISONOUS ANIMALS.

Examples of Animals of a particular prohibited group shall not be construed as limiting the generality of the group.

SCHEDULE "B" TO BY-LAW 0000-2013 APPROVED ENCLOSURE REQUIREMENTS FOR PROHIBITED OR DANGEROUS ANIMALS

Enclosure for Venomous Reptiles

- 1. Enclosures for venomous reptiles shall be kept indoors in a secure and locked area. All enclosures should be constructed of wood, fibreglass, ABS plastic or metal. Enclosures must be secure and key locked. All enclosures shall be kept within a secured (escape proofed) and locked area indoors. There shall be a sign displaying the words "LIVE VENOMOUS ANIMALS, DO NOT TOUCH", which shall be posted outside the secure and locked area and include a listing of emergency phone numbers.
- 2. The Owner shall ensure that antitoxins are provided pursuant to section 7.1 of the by-law.
- 3. The Owner of the venomous reptiles shall notify the local fire/rescue department to the fact that prohibited or dangerous animals are being kept within the Premises.

Enclosures for Constrictors

4. Enclosure for constrictors including, but not limited to Phthoridia (large Python) and Boidae (Boa), shall be constructed of solid wood, 1/2" thick of fibreglass, metal or PVC plastic of a size to allow movement of the Animal. All enclosures must be kept indoors and shall be secure and key locked. All provisions for safekeeping and care and maintenance must be adhered to.

Enclosures for Felids

- 5. Enclosures for Felids (large cats) shall be no less than thirty (30) x forty(40) feet comprised of nine (9) gauge chain-linked fence, which fence is to be ten (10) feet high with an additional three (3) feet on an angle to a height of twelve (12) feet. The top of the enclosure must be enclosed and shall be comprised of nine (9) gauge chain-linked fence with the required trusses. Main corner posts are to be three (3) inch metal posts. There will be additional cross posts placed horizontally at three (3) feet and six (6) feet from the bottom of the fence. The bottom of the enclosure shall be anchored securely to the ground every two (2) feet. Four inch reinforced mesh shall be attached to the bottom of the enclosure and shall extend no less than three (3) feet into the enclosure and be weighted down by rocks. Such enclosures shall provide an additional secured area attached to the main enclosure for the Felids when the enclosure is being cleaned. The access to the whole enclosure shall be through a double door entry system.
- 6. There is to be a second chain link fence six (6) feet out from the enclosure and at least four(4) feet high. Danger signs must be posted on the outer fence and be visible to the public.
