

THE CORPORATION OF THE  
TOWN OF PELHAM

BY-LAW NO. 3470 (2014)

**Being a by-law to provide for the establishment of a voting place at the institutions or retirement homes known as: Lookout Ridge Retirement Community; Shorthills Villa Retirement Community; and The Woodlands of Sunset; and to provide for reduced voting hours.**

WHEREAS Section 45(7) of the Municipal Elections Act, S.O. 1996, as amended, provides that on voting day, a voting place shall be provided on the premises of a retirement home in which, on nomination day, 50 or more beds are occupied; and

WHEREAS Section 46(3) of the Act permits a municipal council to pass a by-law with respect to a voting place described in subsection 45(7) that is only for the use of residents of the institution or retirement home, providing for reduced opening hours;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWN OF PELHAM ENACTS AS FOLLOWS:

- (1) THAT a voting place shall be provided on the premises known municipally as 1505 Lookout Street, Fonthill, ON L0S 1E5 which is situate within the municipal boundaries of the Town of Pelham and known as “**Lookout Ridge Retirement Community**”; and
- (2) THAT this voting place shall be only for the use of residents of Lookout Ridge Retirement Community; and
- (3) THAT the voting station be open between the hours of **9:00 a.m. and 12:00 p.m.** on Monday, October 27, 2014, being Voting Day in accordance with The Act;

AND FURTHER:

- (4) THAT a voting place shall be provided on the premises known municipally as 1532 Pelham Street, Fonthill, ON L0S 1E3 which is situate within the municipal boundaries of the Town of Pelham and known as “**Shorthills Villa Retirement Community**”; and

(5) THAT this voting place shall be only for the use of residents of Shorthills Villa Retirement community; and

(6) THAT the voting station be open between the hours of **1:00 and 3:00 p.m.** on Monday, October 27, 2014, being Voting Day in accordance with The Act;


AND FURTHER:

(7) THAT a voting place shall be provided on the premises known municipally as 920 Pelham Street, Welland, ON L3C 1Y5 which is situate within the municipal boundaries of the Town of Pelham and known as "**The Woodlands of Sunset**"; and


(8) THAT this voting place shall be only for the use of residents of The Woodlands of Sunset; and

(9) THAT the voting station be open between the hours of **9:00 and 11:00 a.m.** on Monday, October 27, 2014, being Voting Day in accordance with The Act; and
