

THE CORPORATION OF THE
T O W N O F P E L H A M
BY-LAW #359 (1976)

Being a by-law to provide for the
erection of stop signs at inter-
sections.

WHEREAS Section 89 of the Highway Traffic Act,
R.S.O. 1970, Chapter 202 provides that the Council of a municipality
and the trustees of a police village may by by-law, provide for the
erection of stop signs at intersections on highways under its juris-
diction, and every sign so erected shall comply with the regulations
of the Ministry;

NOW THEREFORE COUNCIL OF THE CORPORATION OF THE
TOWN OF PELHAM ENACTS AS FOLLOWS:

(1) That the intersections on highways set out in Column 1 are designated
as intersections where stop signs shall be erected at the locations shown
in Column 2:
