**Being a by-law to amend Schedule "E" to By-law #3578(2015) being a consolidated by-law confirming various appointments to Boards, Commissions, and Committees of the Town of Pelham;**

2. THAT By-Law #3578(2015) be amended to additionally include the appointments as follows, detailed in the attached schedules, as below listed:




