

BY-LAW NO. 1833-77

A BY-LAW TO CHANGE THE NAMES OF
CERTAIN ROADS IN THE TOWN OF PELHAM

WHEREAS the Corporation of the Town of Pelham has requested The Regional Municipality of Niagara to change the names of South Pelham Street, Balfour Street North, Cream Street North and Effingham Street North in order to remove the north and south designation and thereby remove the duplicity and confusion in the said street names.

AND WHEREAS the Regional Council at its meeting on December 16th, 1976, in adopting the Public Works and Utilities Committee Report No. 42 did approve the said name changes of the said streets which are regional roads.

AND WHEREAS pursuant to paragraph 97 of Subsection 1 of Section 354 of The Municipal Act, R.S.O. 1970, Chapter 284, and pursuant to Section 75 of The Regional Municipality of Niagara Act, R.S.O. 1970, Chapter 406, the Regional Council may pass by-laws for changing the names of highways under the jurisdiction of the Regional Corporation.

NOW THEREFORE the Council of The Regional Municipality of Niagara (three-fourths of all the members thereof voting affirmatively) enacts as follows:

1. THAT the name of Pelham Street South as confirmed or otherwise established by the provisions of No. 8 of Schedule "A" to By-law No. 1552 A of the former Corporation of the Township of Pelham lying between the intersection of the said South Pelham Street with King's Highway No. 20 and its intersection with the southerly limits of the Town of Pelham which said Town limits lie on a line passing through the said South Pelham Street at a point distant northerly along the westerly limit of Lot 237 in the former Township of Thorold 1650 feet from the south-west angle of the said lot and parallel to the southerly limit of Lot 1, Concession 10, in the former Township of Pelham said line also being distant 440.73 feet from the south-east angle of Lot 1, Concession 10, in the former Township of Pelham and bounded on the east by Lots 237, 177 and 173 in the former Township of Thorold, Lots 31 to 33 both inclusive according to Registered Plan No. NS-34 for the former Township of Thorold, Lots 1 to 3 both inclusive according to Registered Plan No. 692 for the former Township of Thorold, Lots 1

to 9 inclusive according to Registered Plan No. 670 for the former Township of Thorold, Lots 1 to 15 both inclusive according to Registered Plan No. 678 for the former Township of Thorold, Lots 23 to 27 both inclusive and Lots 70 to 72 both inclusive all according to Registered Plan No. 658 for the former Township of Thorold, Lots 1 to 3 both inclusive according to Registered Plan No. 647 for the former Township of Thorold, Lots 22 to 25 both inclusive and Lots 27 to 34 both inclusive all according to Registered Plan No. 717 for the former Village of Fonthill; and bounded on the west by Lot 1 in Concessions 8, 9 and 10 of the former Township of Pelham, Lots 417 to 421 both inclusive, Lot 170 and Block "C" all according to Plan M-19 for the Town of Pelham, Lots 13 and 1 according to Registered Plan No. 709 for the former Township of Pelham, Lots 10 and 11 according to Plan M-31 for the Town of Pelham, Lots 1, 16, 17, 18 and 19 all according to Registered Plan No. 724 for the former Village of Fonthill, Blocks "F" and "G" according to Plan No. 717 for the former Village of Fonthill, Lots 3, 2 and 33 according to Registered Plan No. 721 for the former Village of Fonthill, Lots 68 to 70 both inclusive according to Registered Plan No. 717 for the former Village of Fonthill, Lots 1 to 6 both inclusive and all lying on the west side of South Pelham Street according to Registered Plan No. 715 for the former Village of Fonthill and Lot 1 lying on the south side of Canboro Road according to Registered Plan No. 715 for the former Village of Fonthill, be changed to Pelham Street and the provisions of No. 8 of Schedule "A" to By-law No. 1552 A of the former Township of Pelham are amended accordingly.

2. (a) THAT the name of that portion of Effingham Street South as confirmed or otherwise established by the provisions of No. 11 of Schedule "A" to By-law No. 1552 A of the former Township of Pelham and lying between River Road and Webber Road and bounded on the east by Lot 5 in Concession 14 and bounded on the west by Lot 6 in Concession 14, both in the former Township of Pelham, be changed to Effingham Street and the provisions of No. 11 of Schedule "A" to By-law No. 1552 A are amended accordingly.

(b) THAT the name of Effingham Street North as confirmed or otherwise established by the provisions of No. 6 of Schedule "A" to By-law No. 1552 A of the former Township of Pelham and lying between King's Highway No. 20 and the intersection of Effingham Street North with the northerly limits of the Town of Pelham and bounded on the east by Lot 5 in Concession 7 in the former Township of Pelham, Lots 1 to 4 both inclusive according to Registered Plan No. 694 for the former Township of Pelham, Lot 5 in Concession 5, Lot 5 in Concession 4, Lot 6 in Concessions 4, 3 and 2, Lot 5 in Concession 2, Lot 4 in Concession 2, Lot 4 in Concession 1, Lot 3 in Concession 1 and Lot 2 in Concession 1, and bounded on the west by Lot 6 in Concession 7, Lots 5 to 8 both inclusive according to Registered Plan No. 694 for the former Township of Pelham, Lot 6 in Concession 5, Lot 5 in Concession 4, Lot 6 in Concession 4, Lot 7 in Concession 4, Lot 7 in Concession 3, Lot 6 in Concession 3, Lot 6 in Concession 3, Lot 6 in Concession 2, Lot 5 in Concession 2, Lot 4 in Concession 1, Lot 3 in Concession 1 and Lot 2 in Concession 1, be changed to Effingham Street and the provisions of No. 6 of Schedule "A" to By-law No. 1552 A are amended accordingly. All references to concessions in this paragraph are concessions lying in the Town of Pelham, formerly in the Township of Pelham.

3. THAT the name of that portion of Cream Street North as confirmed or otherwise established by the provisions of No. 34 of Schedule "A" to By-law No. 1552 A of the former Township of Pelham and lying between Metler Road and Sixteen Road and bounded on the east by Lot 11 in Concession 4 and 5, bounded on the west by Lot 12 in Concessions 4 and 5 both in the former Township of Pelham, be changed to Cream Street and the provisions of No. 34 of Schedule "A" to By-law No. 1552 A are amended accordingly.

4. (a) That the name of that portion of Balfour Street South as confirmed or otherwise established by the provisions of No. 46 of Schedule "A" to By-law No. 1552 A of the former Township of Pelham and lying between Canboro Road and King's Highway No. 20

and bounded on the east by Lot 13 in Concessions 8 and 9 and bounded on the west by Lot 14 in Concessions 8 and 9 all in the former Township of Pelham, be changed to Balfour Street and the provisions of No. 46 of Schedule "A" to By-law No. 1552 A are amended accordingly.

(b) THAT the name of that portion of Balfour Street North as confirmed or otherwise established by the provisions of No. 2 of Schedule "A" to By-law No. 1552 A of the former Township of Pelham and lying between King's Highway No. 20 and Metler Road and bounded on the east by Lot 13 in Concessions 6 and 7 and bounded on the west by Lot 14 in Concessions 6 and 7 all in the former Township of Pelham, be changed to Balfour Street and the provisions of No. 2 of Schedule "A" to By-law No. 1552 A are amended accordingly.

THIS BY-LAW WITH THE CERTIFICATE OF THE JUDGE OF the Judicial District of Niagara South attached, shall take effect from and after their registration thereof in the Registry Office for the Registry Division of Niagara South.
