notice of the application in a form approved by me having been published in the Ontario Gazette on August 6 and August 13 and in The Welland Tribune and St. Catharines Standard on August 4, August 11, August 18 and August 25 and in The Herald on August 2, August 9, August 16 and August 23 and in the Thorold News on August 4, August 11, August 25 and September 1, all as appears by affidavits of publication, filed; no one appearing to oppose the changes proposed by the said by-laws and bill, upon hearing counsel for the applicant:

1. I HEREBY APPROVE the change of names of streets in the Town of Pelham as contained in By-law No. 409 (1977) of the Corporation of the Town of Pelham, and by this certificate do certify such approval.

2. I HEREBY APPROVE the change of names of Pelham Street North to Pelham Street as contained in By-law No. 200 (1977) of the Corporation of the City of Thorold and by this certificate do certify such approval.

3. I HEREBY APPROVE the change of names of certain streets in the Town of Pelham under the jurisdiction of the Regional Municipality of Niagara as contained in Bill No. 1693 of the Regional Municipality of Niagara and by this certificate do certify such approval.
