

# The Corporation of the Town of Pelham

By-law No. 4436(2022)

**Being a by-law to amend By-law #4068(2019), as amended, confirming various appointments to Boards, Commissions, and Committees of the Town of Pelham;**

**And to rename the Town of Pelham Library Board to the Lincoln Pelham Union Public Library Board (Schedule A);**

**And to remove a member from the Lincoln Pelham Union Public Library Board (Schedule A);**

**And to appoint and remove members from the Pelham Summerfest Committee (Schedule N);**

**And to remove members from the Pelham Arts Advisory Committee (Schedule O).**

**WHEREAS** Council of the Corporation of the Town of Pelham deems it desirable and necessary to appoint and remove members of Boards, Commissions, Committees and Municipal Positions;

**AND WHEREAS** By-law #4068(2019), provides for the appointment of individuals to various Boards and Committees;

**AND WHEREAS** on March 7, 2022 Council entered into an agreement with the Town of Lincoln to establish a union public library;

**AND WHEREAS** Council of the Corporation of the Town of Pelham and the Corporation of the Town of Lincoln deem it desirable to rename the library Board to the Lincoln Pelham Union Library Board;

**AND WHEREAS** the Corporation of the Town of Lincoln will appoint Lincoln residents to the Lincoln Pelham Union Library Board by separate By-law;

**NOW THEREFORE** Council of the Corporation of the Town of Pelham Enacts as Follows:

1. THAT By-Law #4068(2019) be amended to remove Schedule A from "Town of Pelham Library Board" to "Lincoln Pelham Union Library Board";
2. AND THAT By-Law #4068(2019) be amended to additionally include the appointments and resignations as follows, detailed in the attached schedules, as below listed:
