



The Corporation of the Town of Pelham

By-law No. 02-2023

Being a By-law to confirm various appointments to Statutory Committees of the Town of Pelham for the 2022-2026 Term of Council;

And to Repeal and Replace By-law 4068(2019), as amended.

WHEREAS section 8 of the *Municipal Act, 2001*, S.O. 2001, c. 25 ("*Municipal Act, 2001*" or "the statute") provides that the powers of a municipality under the statute or any other Act shall be interpreted broadly so as to confer broad authority to enable the municipality to govern its affairs as it considers appropriate and to enhance the municipality's ability to respond to municipal issues;

AND WHEREAS section 9 of the *Municipal Act, 2001* provides that a municipality has the capacity, rights, powers and privileges of a natural person for the purpose of exercising its authority under the statute or any other Act;

AND WHEREAS the Council of the Corporation of the Town of Pelham deems it necessary and desirable to appoint members to Statutory Committees;

AND WHEREAS Council makes appointments to various Statutory Committees and Boards every four (4) years to coincide with the Term of Council;

NOW THEREFORE the Council of the Corporation of the Town of Pelham enacts appointments as follows in the attached schedules, as listed below:

- 1. THAT** appointments to Statutory Committees shall be confirmed as listed in Schedule "A" attached hereto and forming part of this By-law.
- 2. THAT** from time to time, changes to Schedule "A" are necessary due to vacancies created for various reasons, it shall be deemed acceptable for Council to do so by resolution. The resolution be in effect only until the new appointments by-law is brought forward at the usual time at which Council strikes and confirms its appointments, and at which time a new by-law is enacted.

3. Repeal and Enactment

- 3.1. By-laws 4068(2019), 4082(2019), 4089(2019), 4094(2019), 4112(2019), 4124(2019), 4152(2019), 4238(2020), 4290(2020), 4333(2021), 4371(2021), 4395(2021), 4436(2022), 4442(2022), 4446(2022) being by-laws to appoint and remove members to various committees and boards are hereby repealed and replaced.

4. Effective Date

4.1. This By-law shall come into force on the date that it is enacted.
