

# The Corporation of the Town of Pelham

By-law No. 27-2025

Being a by-law to amend By-law 13-2023, confirming various appointments to Advisory Committees of the Town of Pelham for the 2022-2026 Term of Council and to remove and appoint a Council representative to the Pelham Finance and Audit Committee and the Environmental and the Climate Adaptation Advisory Committee.

**WHEREAS** the Council of the Corporation of the Town of Pelham deems it necessary and desirable to appoint members to Advisory Committees;

**AND WHEREAS** on December 5, 2022, Council approved the establishment of the Pelham Finance and Audit Committee and subsequently appointed Council representatives on February 21, 2023;

**AND WHEREAS** on May 3, 2023, Council approved the establishment of the Environmental and Climate Adaptation Advisory Committee and appointed Council representatives on September 20, 2023;

**AND WHEREAS** from time to time, it is necessary to fill vacancies on such Advisory Committees;

**NOW THEREFORE** the Council of the Corporation of the Town of Pelham enacts appointments as follows in the attached schedule, as listed below:

- 1. THAT appointment and removal to the Pelham Finance and Audit Committee and the Environmental and the Climate Adaptation Advisory Committee shall be confirmed as listed in Schedule "A" attached hereto and forming part of this Bylaw.
- 2. THAT from time to time, changes to Schedule "A" are necessary due to vacancies created for various reasons, it shall be deemed acceptable for Council to do so by resolution. The resolution be in effect only until the new appointments by-law is brought forward at the usual time at which Council strikes and confirms its appointments, and at which time a new by-law is enacted.

#### 3. Effective Date

3.1. This By-law shall come into force on the date that it is enacted.
