

THE CORPORATION OF THE

BY-LAW #510 (1979)

Being a by-law to amend dog control By-law
#462 (1978) respecting the due date of licenses
and the fees.

WHEREAS Council of the Corporation of the Town of Pelham
deems it desirable to amend the dog control By-law #462 (1978) with
respect to the due date of licenses and the fees;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWN
OF PELHAM ENACTS AS FOLLOWS:

(1) THAT the following parts and sections of By-law #462 (1978)
be amended as follows:

(a) Part II - Licensing & Registration - Section 2 (a)
be deleted and the following be substituted therefor and known as
Section 2 (a) - "Subject to Subsection (c), the owner of a dog in
the Town of Pelham shall pay to the Treasurer of the Corporation
of the Town of Pelham in each year, a licence fee as follows:

\$7.00 for a spayed or neutered dog (upon the production
of a certificate, in writing, of a veterinary surgeon that a dog,
male or female, has been neutered or spayed);

\$7.00 for each additional spayed or neutered dog;

\$10.00 for each unneutered male dog

\$10.00 for each unspayed female dog

\$25.00 for kennel licence provided that the owner holds
a Canadian Kennel Club registration, plus \$1.00 per tag.
Dog Tag Replacement Fee - \$1.00 per tag."

(b) Part II - Licensing & Registration - Section 2, Sub-
section (c) be deleted and the following be substituted therefor
and known as Section 2 (c) - "The licence fee after April 1st. of
each year shall be as follows:

\$14.00 for a spayed or neutered dog (upon the production
of a certificate, in writing, of a veterinary surgeon that a dog,
male or female, has been neutered or spayed);

\$14.00 for each additional spayed or neutered dog;

\$20.00 for each unneutered male dog

\$20.00 for each unspayed female dog

\$30.00 for kennel licence provided that the owner holds a
Canadian Kennel Club registration."

(c) Part II - Licensing & Registration - Section 3 be
amended by deleting the following word in the third line of Section
3 "March" and replacing it with the word "April" so the third line
of Section 3 now reads as follows: "----- "Upon payment of the licence
fee, the said Treasurer shall issue to the owner a licence valid
until the 31st. day of December next ensuing. On or before April
1st. of each succeeding year, a new licence shall be taken out for
the keeping of every dog for such year, in accordance with the
schedule of fees included in Section 2 above."

(d) Part II - Licensing & Registration - Section 8 shall be amended by deleting the following word in the first line "March" and replacing it with the word "April" so the first line of Section 8 will now read as follows: ----- "After the 1st. day of April in each year, it shall be"

(2) THAT By-law #462 (1978), be amended in accordance with the provisions of this by-law, that the balance of By-law #462 (1978) remain unchanged and in force and effect.

(3) THAT THIS amending by-law take force and effect upon ~~third~~ reading and passing by Council.
