- 1. Section 4 is hereby modified by the addition after subsection (f) of two further subsections (g) and
 - Schedules Al, A2, B and C are hereby amended by changing the existing scales to metric
 - Schedule C is hereby further amended in the (h) Legend by changing the figure 100 feet to 30 m and the figure 96 feet to 29 m.

As thus modified, this amendment is hereby approved pursuant to Section 17 of The Planning Act, as Amendment No. 5 to the Official Plan for the Pelham Planning Area.

SECTION 1

TITLE AND COMPONENTS OF THIS AMENDMENT

- 1. This Amendment shall be referred to as Amendment No. 5 to the Official Plan of the Pelham Planning Area. The Pelham Planning Area was established on January 1st, 1970 with the inception of the Regional Municipality of Niagara. The Town of Pelham forms a subsidiary Planning Area within the Regional Planning Area.
- 2. This Amendment applies to the Official Plan of the Pelham Planning Area as approved by the Minister of Housing on May 23rd, 1974.
- 3. Sections 1 to 5 inclusive constitute this Amendment.

SECTION 2

PURPOSE OF THIS AMENDMENT

The purpose of this Amendment is to amend Sections 1 and 3 of the Official Plan of the Pelham Planning Area by substituting metric units for all imperial units therein.

SECTION 3

BASIS OF THIS AMENDMENT

In letters to all municipalities in April, 1978, October, 1978 and July, 1979, the Minister of Housing requested the conversion of existing official plans to metric units and that such conversions take place before December 31st, 1979.

SECTION 4

THE AMENDMENT

The Official Plan of the Pelham Planning Area is hereby amended to give effect to the following:

- (a) The words twenty-five acres are replaced by the figures 10.0 hectares in Section 1.12.
- (b) The words ten acres are replaced by the figures 4.0 hectares in Section 1.15.
- (c) The words two acres are replaced by the figures 0.8 hectares in Section 1.15.1.
- (d) The words one acre are replaced by the figures 0.4 hectares in Section 1.15.2.

SECTION 4

THE AMENDMENT (cont'd)

- (e) The figures 10 acres and 5 acres are replaced by the figures 4.0 hectares and 2.0 hectares respectively in Section 3.4.
- (f) The words five acres are replaced by the figures 2.0 hectares in Section 3.5.1.
