Being a by-law to regulate the discharge of firearms within the limits of the Town of Pelham.

WHEREAS Paragraph 29 of Subsection 1 of Section 379 of the Municipal Act, provides that Council may by by-law prohibit or regulate the discharge of guns or other firearms, air guns and spring-guns or any other class or type thereof in the municipality or in any defined area or areas thereof;

AND WHEREAS Council deems it advisable to regulate the discharge of such guns or other firearms within that part of the municipality hereinafter described;

NOW THEREFORE COUNCIL OF THE CORPORATION OF THE TOWN OF PELHAM ENACTS AS FOLLOWS:

(1) Except as hereinafter provided, no person shall discharge any gun or other firearm, air-gun or spring-gun or any class or type thereof within the following defined areas of the Town of Pelham namely:

Area #1

COMMENCING at the intersection of Pelham Street South and Quaker Road;

THENCE easterly along the centre line of Quaker Road to the CNR tracks;

THENCE northerly along CNR tracks to Port Robinson Road;

THENCE easterly along Port Robinson Road to the centre of Station Street;

THENCE northerly along Station Street to the south side of Highway #20;

THENCE north-easterly along the south side of Highway #20 to the intersection with Hurricane Road;

THENCE westerly along the centre line of Hurricane Road to Pelham Street North;

THENCE northerly along the centre line of Pelham Street North to the intersection of Overholt Road;

THENCE westerly along the centre line of Overholt Road to Haist Road North (now known as Haist Street);

THENCE southerly along the centre line of Haist Road North (now known as Haist Street) to the intersection of a line parallel to Tice Road;

THENCE westerly along this line to the intersection of Tice Road and Lookout Street;

THENCE southerly along the centre line of Lookout Street to Highway #20;

THENCE southerly along a line parallel to Lookout Street across Canboro Road and to Hillcrest Road (now known as Pancake Lane);

THENCE easterly along the centre line of Hillcrest Road (now known as Pancake Lane) to Haist Road (now known as Haist Street);

THENCE southerly along the centre line of Haist Road (now known as Haist Street) to the intersection of a line parallel to Welland Road;

THENCE north-easterly along the centre line parallel to Welland Road to the intersection of Pelham Street South (now known as Pelham Street);

THENCE southerly along the centre line of Pelham Street South (now known as Pelham Street) to the point of commencement and being the area shown cross hatched on the plan marked Schedule "A" which is attached hereto and forms a part of this by-law.

Area #2

The area known as the Fenwick Area and more particularly described as follows:
ALL of Lot 14, and Lot 15, the east half of Lot 16 all in

ALL of Lot 14, and Lot 15, the east half of Lot 16, all in Concession 9.

THE west half of Lot 15, and the east half of Lot 16, Concession 10 and being the area cross hatched on the plan and marked as Schedule "A" which is attached hereto and forms part of this by-law.

Area #3

COMMENCING at the intersection of the centre line of Memorial Drive and the centre line of Balfour Street;

THENCE easterly along the centre line of Memorial Drive to its intersection with the centre line of Cream Street;

THENCE southerly along the centre line of Cream Street to a point 500 feet north of Canboro Road;

THENCE north-easterly along a line parallel to and 500 feet south of Canboro Road to a point in the easterly limit of Lot 4 in the 8th. Concession;

THENCE south along the said east limit of Lot 4 to a point 500 feet south of Canboro Road;

THENCE south-westerly along a line parallel to and 500 feet south of Canboro Road to its intersection with the centre line of Balfour Street;

THENCE north along the centre line of Balfour Street to the place of beginning.

Area #4

COMMENCING at a point in the centre line of Metler Road distant easterly 500 feet from the centre line of Cream Street;

THENCE northerly in a straight line parallel to the centre line of Cream Street 500 feet to a point;

THENCE westerly in a straight line parallel to the centre line of Metler Road to a point distant 500 feet west of the centre line of Balfour Street;

THENCE southerly in a straight line parallel to the centre line of Balfour Street to a point distant 500 feet south of the centre line of Metler Road;

THENCE easterly in a straight parallel to the centre line of Metler Road to a point 500 feet east of the centre line of Cream Street;

THENCE northerly in a straight line parallel to centre line of Cream Street to the place of beginning.

Area #5

COMMENCING at the intersection of the centre line of Pelham Street and the centre line of Hurricane Road;

THENCE easterly along the centre line of Hurricane Road to its intersection with the centre line of Highway #20;

THENCE northwesterly along the centre line of Highway #20 to its intersection with the municipal boundary of the Town of Pelham and City of Thorold;

THENCE northerly, southwesterly and northwesterly in and along the municipal boundary of the Town of Pelham and the City of Thorold to its intersection with the centre line of Pelham Street;

THENCE southerly along the centre line of Pelham Street to the place of beginning.

Area #6

CONSISTING of all of Lot 3 in the 9th. Concession;

THE north half of Lot 3 in the 10th. Concession;

ALL of Lot 2 in the 10th. Concession;

AND ALL of that portion of Lot 1 in the 10th. Concession which is within the boundaries of the Town of Pelham.

- (2) The discharge of any firearm, regardless of calibre, which incorporates a rifled barrel in its construction is hereby prohibited in the Town of Pelham. And further that the use of any projectile or slug or shot larger than #2 gauge is hereby prohibited in the Town of Pelham, except during the period established by the Ministry of Natural Resources for the hunting of deer, at which time regulations established by the Ministry of Natural Resources shall prevail.
- (3) This by-law shall not apply to the destruction of a farm or domestic animal for humane reasons, or the destruction, by the owner, his agent or servant on the owners property, in the course of protecting his livestock or crops, of rodents, rabbits or pestiferous birds or animals provided that he type of gun used is a shot gun using shot no larger than #2 gauge and that the shot gun is not discharged in a negligent manner and further than an

agent or servant of an owner has the owner's consent in writing. For the purpose of this section, owner shall include any person who is the owner of an interest in the land entitling him to possession of it and shall include a tenant farmer.


- That the discharge of any firearm within the distance of (4)One Thousand Feet (1,000') from any building used for raising of poultry for commercial purposes and within the distance of Five Hundred Feet (500') from any other type of building is prohibited.
- Nothing in this by-law contained shall prevent any police (5) constable or other public officer from discharging a gun or other firearm in the ordinary course of duty, when such duty involves the use of a gun or other firearm.
- Any gun or other type of firearm, air-gun or spring-gun (6) or any class or type thereof discharged contrary to the provisions of this by-law may be seized and impounded by any police officer of the Corporation.
- Every person who contravenes any of the provisions of this by-law shall, upon conviction thereof, forfeit and pay at the All attacked discretion of the convicting Magistrate a penalty not exceeding BL# 2416 (2002) (exclusive of costs) the sum of \$300.00 for each offence.

By-law #854 (1969) of the former Village of Fonthill and (8) By-law #1701 (1965) of the former Township of Pelham are hereby repealed.

DISCHARGE OF FIREARMS BY-LAW
