

THE CORPORATION OF THE
T O W N O F P E L H A M
BY-LAW #582 (1980)

Being a by-law to provide for the erection of
stop signs and yield signs at intersections.

WHEREAS Sections 89 and 90 of The Highway Traffic Act, R.S.O. 1970, Chapter 202 provides that the Council of a municipality may by by-law provide for the erection of stop signs and yield signs at intersections on highways under its jurisdiction and every sign so erected shall comply with the regulations of the Ministry of Transportation & Communications;

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWN OF PELHAM ENACTS AS FOLLOWS:

(1) THAT the intersections on highways set out in Column 1 are designated as intersections where stop signs shall be erected at the locations shown in Column 2.

Concord Street & Haist Street	Eastbound on Concord Street
D'Everardo Drive & Berkwood Place	Westbound on D'Everardo Drive
D'Everardo Drive & Haist Street	Eastbound on D'Everardo Drive
Berkwood Place & Haist Street	Eastbound on Berkwood Place
Woodstream Boulevard & Pancake Lane	Northbound on Woodstream Boulevard
Deer Park Crescent & Nursery Road	Northbound on Deer Park Crescent
Nursery Road & Spruceside Crescent	Eastbound on Nursery Road
Millbridge Crescent & Spruceside Crescent	Eastbound on Millbridge Crescent
Fallingbrook Drive & Spruceside Crescent	Southbound on Fallingbrook Drive
Parkhill Road & Millbridge Crescent	Southbound on Parkhill Road
Woodstream Boulevard & Spruceside Crescent	Southbound on Woodstream Boulevard
Fallingbrook Drive & Spruceside Crescent	Northbound on Fallingbrook Drive
Deer Park Crescent & Spruceside Crescent	Eastbound on Deer Park Crescent

(2) THAT the intersections on highways set out in Column 1 are designated as intersections where yield right-of-way signs shall be erected at the locations shown in Column 2.

Dogwood Crescent & Berkwood Place	Eastbound on Dogwood Crescent

(3) THAT the penalties provided in Section 152 of The Highway Traffic Act shall apply to offences against this by-law.

(4) THAT each designation made by Section 1 and 2 shall not become effective until said signs have been erected in accordance with the regulations of The Highway Traffic Act.
