WHEREAS the party of the first part is owner of the lands hereinafter described.

AND WHEREAS the parties hereof are desirous of entering upon an agreement for the temporary installation of water services.

AND WHEREAS the Municipal Corporation desires to apply to the Ontario Municipal Board for approval of debentures to construct a 6" water main on North Pelham Street in front of the lands herein described.

- 1. The owner will be permitted temporary water services to be hooked up to the existing 1" water line.

- The owner undertakes and agrees to indemnify the municipality from any action presently connected with the 1" water line arising from any decrease in water pressure or volume.
