

THIS INDEMNIFICATION AGREEMENT made in duplicate this
14th day of March, 1980.

B E T W E E N:

RICENBERG DEVELOPMENTS LIMITED, a company incorporated
under the laws of the Province of Ontario,
hereinafter called RICENBERG,

OF THE FIRST PART,

- and -

THE CORPORATION OF THE TOWN OF PELHAM,
hereinafter called THE TOWN,

OF THE SECOND PART.

WHEREAS the Town did grant to Ricenberg, permission to
enter onto the lands described in Schedules "A" and "B"
for the purpose of constructing thereon a storm sewer and
a sanitary sewer.

AND WHEREAS part of the consideration for the granting of
the permission was that Ricenberg would enter into this
indemnification Agreement.

NOW THEREFORE IN CONSIDERATION of the granting of the
said permission and the sum of TEN----(\$10.00)---- DOLLARS
receipt whereof is hereby acknowledged, Ricenberg doth
hereby agree that it will at all times hereinafter indemnify
and save harmless The Town from and against any and all
liabilities, loss, costs, damages, legal fees, and expenses
of whatever kind or nature which the Town may sustain or incur
by reason of Ricenberg, its workmen, contractors, agents,
installing, maintaining, repairing, altering or removing
a storm sewer and a sanitary sewer over the lands described
in Schedules "A" and "B".

THIS AGREEMENT shall enure to the benefit of and be binding
upon the parties hereto, their successors and assigns.
